REGULAR MEETING:

The regular meeting of The Climate Change Advisory Committee (CCAC) was called to order on May 21, 2013 at 10:04 a.m. by the Committee Chairperson, Christina Simeone. Members and guests introduced themselves. With the seven members present and the three official proxies a quorum was established.

In agreement with the PA DEP, Ms. Simeone announced that the minutes of the February 9, 2013 meeting, along with the minutes of the previous meetings that have not yet been accepted, would not be discussed or voted on for acceptance at this meeting. This was done in order to save time and facilitate the voting upon of work plans needed for the Climate Change Action Plan.

Mr. Van Orden reported on the vacancy created within the Department's Climate Change Program with the departure of Mr. Sherrick.

WORK PLAN DISCUSSION & VOTING:

Forty-one (41) work plans were distributed to the committee members prior to this meeting for review and endorsement consideration. The following work plans were discussed and either voted on for endorsement or tabled awaiting edits:

- **Reforestation** Not voted on, tabled for editing
- Forest Protection Initiative Acquisition Not voted on, tabled for editing due to technical issues
- Forest Protection Initiative Easement Not voted on, tabled for editing due to technical issues

- **Durable Wood Products** Not voted on, tabled for editing due to technical issues
- **Urban Forestry** Endorsed 10 yea 0 nay -0 abstained
- Management Intense Grazing Not voted on, tabled for editing due to technical issues or possible exclusion
- No-Till Farming Endorsed 10 yea 0 nay 0 abstained
- **Bio-Fuels Development and in State Production Incentive Act** Not voted on, tabled for editing due to technical issues
- Manure Digesters Not voted on, tabled for editing due to technical issues
- Foodshed Development Not voted on, tabled for editing due to technical issues
- **Re-Roof Pennsylvania** Not voted on, tabled for editing due to technical issues
- **Diesel** *Anti-Idling* **Program** Not voted on, tabled for editing due to questions about revisions based on actual implementation
- PA Clean Vehicles and Program and Federal CAFÉ Standards Not voted on, tabled for editing
- Increasing Ridership and Efficient Passenger Transit Not voted on, tabled for editing

A total of 15 of the 41 work plans were acted on by the committee. Three work plans received the committee's endorsement.
