Amendment to Consent Order and Agreement

Whereas, PPL Electric Utilities Corporation ("PPL Electric"), PPL Generation, LLC ("PPL Generation") and PPL Gas Utilities Corporation ("PPL Gas") are parties to a Consent Order and Agreement with the Commonwealth of Pennsylvania Department of Environmental Protection ("DEP" or "Department") dated February 2005 ("2005 COA"), under which PPL Generation, PPL Gas and PPL Electric each commits to undertaking certain work as set forth in the 2005 COA, including investigation and remediation of certain contaminated sites, and plugging of certain abandoned wells; and

Whereas, PPL Corporation, the parent company of PPL Gas has announced an intention of selling PPL Gas; and

Whereas, in light of this anticipated sale, the parties desire to amend the 2005 COA to remove PPL Electric and PPL Generation from that agreement; and

Whereas, there are no remaining PPL Generation sites but there are a few PPL Electric sites that the Parties wish to address under a separate agreement with PPL Electric; and

Whereas, PPL Gas wants to update the list of MGP sites under Exhibit A and to add twenty two [22] abandoned wells to the list of wells under Exhibit C to be plugged under the 2005 COA and to extend the deadlines under the 2005 COA to allow for these additional wells to be plugged.

Now therefore, the parties agree that on this 18th day of April, 2008, the 2005 COA is amended as follows:

- 1. PPL Generation and PPL Electric are hereby removed as parties to the 2005 COA and all references to sites owned by them are hereby deleted.
- 2. An updated Exhibit A is attached.
- 3. Paragraph 11(a) is amended to add the following sentence: "A Final Report shall be submitted for every MGP Site on Exhibit A by no later than December 31, 2011 unless otherwise agreed to by both the PA DEP and PPL Gas in writing"
- 4. Exhibit B is hereby revised to read as follows: "Intentionally left blank".
- 5. Section 25 of the 2005 COA is amended to require 272 wells to be plugged by December 31, 2008 and all abandoned wells listed on Exhibit C to be plugged by no later than December 31, 2013. A revised Exhibit C is attached hereto.
- 6. The termination date in section 43 is extended to December 31, 2013.

In all other respects the 2005 COA remains in full force and effect.

IN WITNESS WHEREOF, the parties hereto have caused this Amended Consent Order and Agreement to be executed by the duly authorized representatives. The undersigned representatives of PPL Generation, PPL Electric and PPL Gas certify under penalty of law, as provided by 18 Pa.C.S. § 4904, that they are authorized to execute this Amended Consent Order and Agreement on behalf of the respective corporations; that PPL Generation, PPL Electric and PPL Gas each consents to the entry of this Amended Consent Order and Agreement; and each knowingly waives its right to appeal this Amended Consent Order and Agreement which rights may be available under Section 4 of the Environmental Hearing Board Act, the Act of July 13, 1988, P.L. 530, No. 1988-94, 35 P.S. § 7514; the Administrative Agency Law, 2 Pa.C.S. § 103(a); and Chapters 5A and 7A, or any other provision of law.
