# **PUBLIC COMMENT**

John Spade, diesel instructor had questions about gas testing with the ECOM, battery life, and ECOM accuracy and variations. He also inquired if there was any other gas analyzer that could be used to comply with Chapter 4 of the Safety Laws of Pennsylvania for Underground Bituminous Coal Mines.

Discussions followed regarding industry practices and equipment used to comply with the laws. It was noted that Chapter 4 does not mention a specific gas analyzer to be used, but the ECOM has been the standard and chosen analyzer since the beginning of using diesel equipment in Pennsylvania underground coal mines.

Discussion followed on information found in the ECOM operation manual, standards used for testing, and practical use of the ECOM.

John said he may be doing more classroom comparisons of gas analysis results.

Paul Borchick asked if there was any further public comment. There was none.

Mr. Borchick thanked those present for their participation with the Diesel TAC throughout the past thirteen years and informed them that he would not be seeking reappointment when his term expires on May 17, 2022.
