DEPARTMENT STATUS REPORT

In a letter dated, January 22, 2014, the Commonwealth of Pennsylvania, Department of Environmental Protection ("DEP") notified Hilcorp Energy Company ("Hilcorp") of DEP's determination that the Application for Well Spacing Units was materially deficient and incomplete and, therefore, not a "proper" application under the Oil and Gas Conservation Law. To correct the material deficiencies with the Application, DEP requested that Hilcorp provide information and documents as identified in the letter, dated January 22, 2014.

Pursuant to the Hearing Officer's Order, dated February 19, 2014, Hilcorp has now provided the information and documents that DEP requested in the January 22, 2014 letter. Hilcorp provided paper and/or accessible electronic copies of the requested information and documents to DEP on February 27, and 28, 2014, and March 7, 2014.

Accordingly, pursuant to the Hearing Officer's Order, dated February 19, 2014, DEP has until March 14, 2014, to "either notify the Hearing Officer and Hilcorp that the application is complete and that the hearing as scheduled should move forward or file a Motion to Dismiss with the Hearing Officer stating why the hearing should not occur."

The Department anticipates being able to file such notice or Motion to Dismiss before March 14, 2014.
