## Dear Mr. Gordon:

Under the authority of Pennsylvania's Clean Streams Law, the Department of Environmental Protection (DEP), the Chester County Conservation District (CCCD), and the Delaware County Conservation District (DCCD) have approved your request for the major permit amendments listed below under the Erosion and Sediment Control General Permit for Stormwater Discharges Associated with Oil and Gas Activities (ESCGP). The latest versions of the Notice of Intent (NOI) and all supporting documents, including the Erosion and Sediment Control (E&S) Plan and Post Construction Stormwater Management (PCSM) Plan, are incorporated into this approval.

- 1. Upper Uwchlan Township, Chester County. The horizontal directional drill (HDD) S3-0280 site modifications are for a change in the route and installation method for the 16- and 20-inch diameter pipeline previously permitted as HDD. The proposed installation method for both the 16- and 20-inch diameter pipelines is for open cut installation and one conventional bore. The proposed route will cross an Exceptional Value (EV) wetland (WLQ76) and one stream (SQ83) referred to locally as Meadow Creek and portions of three floodways.
- 2. West Whiteland Township, Chester County. The HDD S3-0400 site modifications are for the change in the HDD installation method for the 20-inch diameter pipeline to an open cut installation and a direct bore under the Exton Bypass (State Route 30), AMTRAK (American Track National Railroad Passenger Corporation), Norfolk Southern Railroad, and wetland WL-K21.
- 3. Middletown Township, Delaware County. The HDD S3-0620 site modifications are for a change in the HDD installation method for the 20-inch and portions of the 16-

inch diameter pipelines to a conventional open trench construction through Wetland WL-II and Stream S-I2, conventional auger bore under Glen Riddle Road, and a direct pipe under Riddlewood Drive and the Southeast Pennsylvania Transportation Authority's (SEPTA) Railroad.

Your coverage under the ESCGP, will continue through E&S Permit No. ESG 01 000 15 001, which became effective on February 13, 2017, and will expire on February 12, 2022. Please note that the expiration date for your coverage has not changed as a resuly of this amendment. If stormwater discharges associated with oil and gas activities are expected to continue beyond the expiration date of your ESCGP coverage, you must apply to renew your coverage at least 180 days prior to the expiration date.

Please review the ESCGP Permit and any special conditions listed in Attachment A of the permit (if applicable) carefully and contact this office if you have any questions.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board), pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:

Appeals must be filed with the Board within 30 days of receipt of notice of this action unless the appropriate statute provides a different time. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.
