On behalf of PennEast Pipeline Company, LLC (PennEast), AECOM respectfully submits this request for extension to respond to the Pennsylvania Department of Environmental Protection's (PADEP) July 3, 2019 Technical Deficiency Letters for the PennEast Pipeline Project (Project). In response to comments the PADEP provided on the Luzerne, Carbon, and Northampton County Joint Permit Applications, PennEast has revisited a few select locations within the Project's proposed construction workspace to re-evaluate current conditions of wetland and watercourse delineations that were completed in 2015. As discussed with a PADEP reviewing biologist and the USACE project managers, PennEast proposes a couple of changes to the wetland and watercourse delineations as a result of verification visits AECOM completed in July and August 2019.

PennEast has invited both agencies to attend site visits in late-August to review the changes. Due to the limited amount of time between the site visits scheduled on August 22 and 29, 2019 and the September 2, 2019 deadline for submitting responses to PADEP's technical deficiency comments, PennEast would have insufficient time to modify Project Erosion and Sediment Control plans and incorporate any changes into the technical deficiency response materials for the Erosion and Sediment Control General Permit application before the September 2, 2019 deadline. PennEast therefore respectfully requests an extension to incorporate any Project changes that may result from the site visits.
