The purpose of this hearing is to solicit input on water resources management issues in the Lower Susquehanna basin. This hearing satisfies the requirements of Section 3115(b)(1)(I) of Act 220 of 2002, the Water Resources Planning Act, which requires that each regional committee to hold at least one combined public meeting and hearing within its region to solicit input on water resources

management and water resources planning within the region. Notice of this meeting was published in the *Pennsylvania Bulletin* on February 5, 2005, and again on April 30, 2005. The meeting was also advertised in the Harrisburg Patriot News.

In order to give everyone an equal opportunity to comment this evening, I would like to establish the following ground rules:

1. I will first call upon the witnesses who have preregistered to testify at this evening's hearing as included on the schedule of witnesses. After hearing from these witnesses, I will provide any other interested parties with the opportunity to testify as time allows.
2. Oral testimony is limited to ten minutes for each witness.
3. Organizations are requested to designate one witness to present testimony on its behalf.
4. Each witness is asked to submit three written copies of his or her testimony to aid in transcribing the hearing. Please hand me your copies prior to presenting your testimony.
5. Please state your name and address for the record, prior to presenting your testimony.
6. We would also appreciate your help in spelling names and terms that may not be generally familiar so that the transcript can be as accurate as possible.

In addition to or in place of oral testimony presented at today's hearing, interested persons may also submit written comments on this proposal. All comments must be received by the Water Planning Office on or before June 30, 2005. All comments received at today's hearing, as well as written comments received by June 30, 2005, will be considered by the Regional Water Resources Committee, as we develop the regional component of the state water plan. An official comment/response document will not be prepared for comments received at this Hearing.
