Overview – Why We Are Here

- Chapters 91 (WQM) & 92a (NPDES) Fee Increase proposals discussed with WRAC on March 24, 2016 and September 21, 2016
- Since then, budget projections show new revenues needed sooner than previously anticipated
- We are proposing to eliminate the 5-year phase-in period

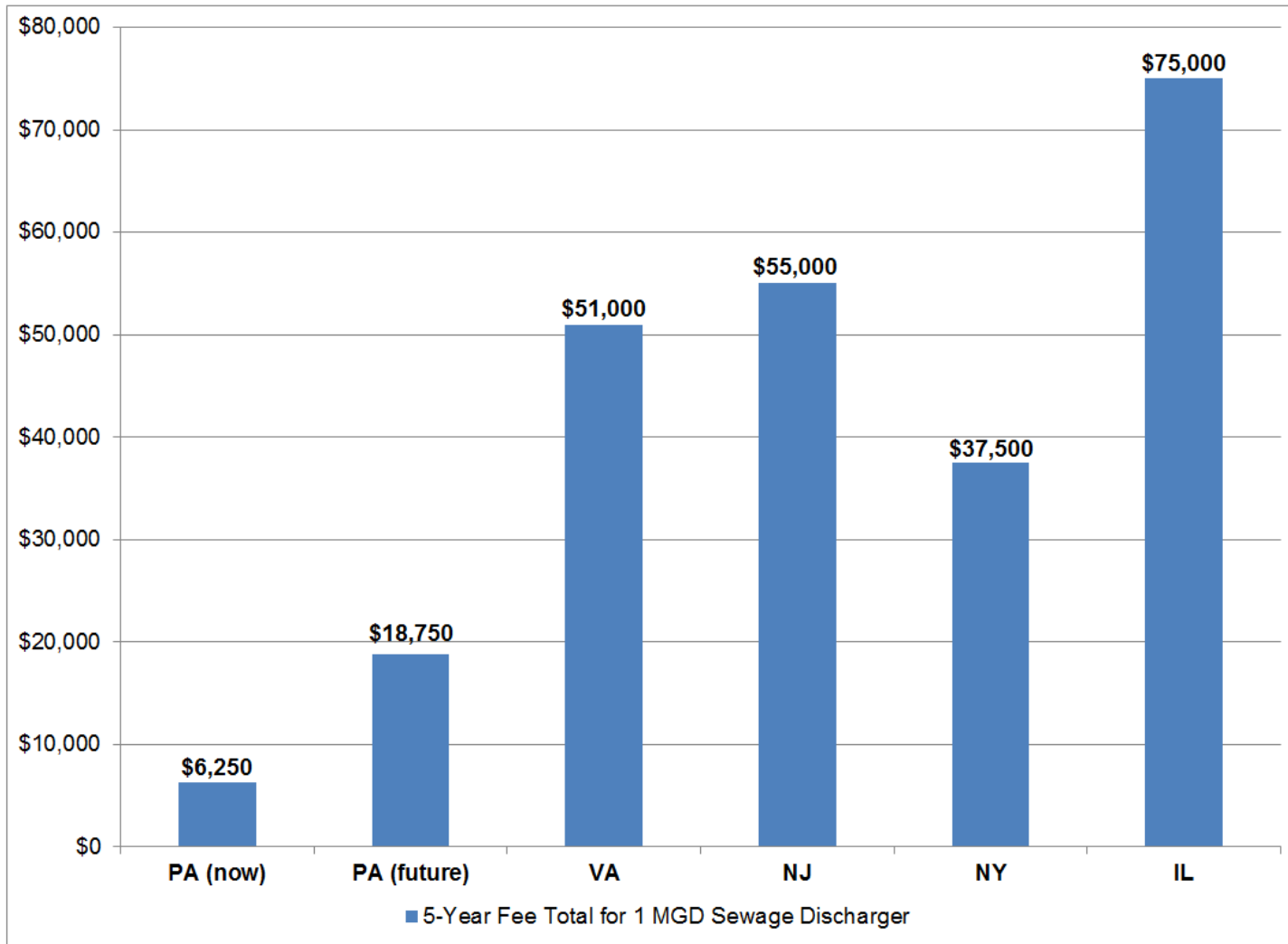
