4. Chapter 105, Dam Safety and Water Management Fees Rulemaking (25 Pa Code, Chapter 105) – Jeff Means

The Environmental Quality Board (EQB) proposes to amend Chapter 105 (relating to dam safety and waterway management). The amendments update existing fees and include additional fees for activities performed by DEP. This Rulemaking was published for comment as proposed by the EQB on January 28, 2012. DEP is now preparing to present this final rulemaking to EQB. (Action item)

5. Technical Guidance Document (TGD)# 362-4180-006; Civil Penalty Assessment

Informal Hearing Procedure for Water Quality Operations – Robert Kachonik This draft TGD has been developed to establish standardized instructions to be used by DEP Water Quality Field Operations staff for the assessment of civil penalties for violations of National Pollutant Discharge Elimination System (NPDES) permits. This TGD was originally published as draft on January 30, 2009. There were five commentators on this TGD. DEP is presenting this TGD to inform WRAC of the changes between draft and final. (Informative, No action required)

6. By-laws Discussion - Duke Adams/Vice Chair

At the January 2012 WRAC meeting it was noted that the By-laws have not been visited for some time and may require some updating to reflect current practices of WRAC.
