## **New Business**

## Chapter 93, Proposal of Chloride Criteria

**Rick Shertzer**, <u>rshertzer@state.pa.us</u>, Environmental Program Manager, Water Quality Standards Division of the Bureau of Water Standards and Facility Regulation, presented the Department's proposal to amend Chapter 93 – "Developing a Water Quality Criteria for Chloride to Protect Aquatic Life." The new criteria suggest adopting EPA's National Criteria as of 1988 for chloride.

WRAC members asked questions and commented about the following:

- EPA standards translation and consistencies into low flow
- Applying standards statewide
- Clarification that this is an Instream criteria goal
- Use as a TMDL standard
- Change now versus Chapter 96 recommendations in 2002 of WRAC Committee
- Status of work on sulfates issues and why focus on chloride instead of sulfates
- Concerns that new standard might severely curtail industry
- Concerns about implementation and expense moving forward and the extent of impact on all streams
- How would NPDES permitting be affected
- Whether chloride is the first of many criteria in Chapter 93 that will be looked at
- Planned roll out of the permitting policy with the new regulation
- Reviews on a case by case basis

Marcus Kohl will get back to the WRAC members on the question of how many miles of stream are in non-attainment status. (*Answer added: We anticipate 172 miles listed for salinity/TDS/chlorides in the upcoming Integrated Report.*)

DEP plans to bring this proposal before the EQB while continuing to work on the sulfates issue by December 2009/January 2010. It was pointed out that the attempt will be to keep Chapter 93 and 95 proposals on a parallel track; however they will remain two separate issues.

After no suggestion of questions for the EQB to pose to the public, Bob Wendelgass made the motion to move the package forward to the EQB as a proposed rulemaking. The motion was seconded and adopted by majority vote.

# Update on WRAC Adhoc Subcommittee on TDS

**David Anderson** provided an update on the status of the adhoc subcommittee. This included information from the two previously held subcommittee meetings. Materials from the subcommittee meetings, including meeting minutes, the mission statement, and sector group presentations are or will be posted on the WRAC website.

The next meeting of the subcommittee is scheduled for Friday, October 16, 2009, at DEP's Southcentral Regional Office.

# Suggestions for Next Meeting's Agenda

It was suggested that at a future meeting the Committee have a discussion on meeting procedures and the adoption of a two meeting cycle when WRAC is asked to look at proposed regulations/changes and give a formal recommendation. The first meeting would be for a presentation and questioning session and then WRAC would present its recommendation at the second meeting after a chance for any necessary additional review/questioning.

It was suggested that formation of a subcommittee regarding watershed issues be discussed. It was also suggested a broad based policy discussion on watershed management be presented by DEP at the next scheduled meeting.
