General TAC Business

Brion Johnson, Chairman, called the meeting to order.

Motion made by Mike Sienkiewicz to approve the minutes of the May 7, 2008 TAC Board meeting. Seconded by Daniel Standish. Motion carried unanimously.

Chapter 109 Drinking Water General Update

Lisa Daniels provided an overview of the final proposed changes to Chapter 109 for a general update. These changes are necessary to address a number of primacy issues related to the implementation of regulatory requirements for the Phase 2/5 Rule, the Arsenic Rule and the Lead and Copper Rule. Mike Sienkiewicz made a motion to submit letter to the Department under Chairman Johnson's signature stating support for the changes with the comments that were developed by the group. The motion was seconded by Serena DiMagno. Motion carried unanimously. A copy of this letter is attached.

Chapter 109 Drinking Water Public Notification Revisions

Deb Rotz provided an overview on the final proposed changes to Chapter 109 related to public notification. Daniel Standish made a motion to change the language in Section 407(a)(9) on page 1 as follows:

"Other violations and situations not covered in (a)(1) through (8) that have a significant or serious effect on human health to require a public notice under this subchapter."

Mike Sienkiewicz seconded the motion. Votes were 3 supporting the motion, 11 opposed. Motion failed. Major reason cited for the decision to vote against the motion was due to the fact that the existing language is necessary to meet federal standards. While the change would limit the Department's discretion, changing the language as suggested would impact the state's ability to maintain primacy for the Public Notification requirements.

Motion made by Serena DiMagno to send a letter to the Department stating that the TAC Board supports the Chapter 109 Drinking Water Public Notification Revisions with the changes stated in the attached letter. Motion seconded by James Wheeler. Motion passed.

New Business

A workgroup was created to review and provide input to the Department on the program guidelines for Public Notification as it relates to references in Chapter 109 to NSF, DEP and water industry standards and values. This workgroup will make recommendations to the full TAC Board at the next quarterly meeting on Thursday, August 21, 2008 for approval. The meeting of this workgroup was scheduled for Tuesday, July 29, 2008.

Agenda items for the August meeting include presentations on changes to Chapter 109 regarding Fees and the Lead & Copper Rule.

Motion made by Brion Johnson to adjourn meeting. Motion carried unanimously.
