### **General TAC Business**

Brion Johnson, Chairman, called the meeting to order.

Motion made by John Hood to approve the minutes of the June 24, 2008 TAC Board meeting. Motion seconded by Jack Mitchell. Motion carried.

# **Lead and Copper Rule**

Dawn Hissner went over the proposed revisions to Chapter 109 to reflect changes made by the US Environmental Protection Agency for the Lead and Copper Rule. A motion made by Serena DiMagno to send a letter to the Department capturing the comments. In addition, DEP should provide a heads up to industry groups and advisory committees when EPA releases proposed changes to the federal drinking water regulations. Motion seconded by Dan Standish. Motion passed. The letter is attached.

# Results of Subcommittee meeting on Public Notification

Deb Rotz and Serena DiMagno presented the results of the subcommittee that met on July 29, 2008 to review and provide input to the Department on the program guidelines for Public Notification related to references for the use of NSF, DEP and water industry standards and values.

Korah Abraham made a motion to adopt the recommendation of the subcommittee that the requirement to contact social service agencies be eliminated from the regulations and guidance documents. Motion was seconded by Serena DiMagno. The vote was ten in favor, three opposed. Motion passed.

Serena made a motion that the sensitive sub-population be required to notify their water company to get priority notification in case of an emergency, much like what is done by the electric utilities. Dan Standish seconded the motion.

David Collura made a motion to adjourn the meeting, due to the fact the meeting was running late. Since this motion has precedence, no 2<sup>nd</sup> is necessary. Motion did not pass.

Members returned to the previous issue regarding sensitive sub-populations. Discussion continued. A motion to withdraw the motion was made by Serena, Seconded by Lee Koch.

Mike Sienkiewicz made a motion to submit the recommendations of the subcommittee to the Department, recognizing that the subcommittee did not reach consensus on all the issues and recommendations. Program staff can then determine how best to modify the guidance documents in response to the input captured in the subcommittee report. A copy of this report is attached. Serena seconded the motion. Motion passed.

Motion to adjourn made by Jack Mitchell. Motion carried unanimously. Board adjourned.
