#### **Approval of Minutes:**

#### **New Business:**

### **Chapter 96**

Ann (Smith) Roda (annsmith@dep.state.pa.us), Water Planning Office, presented an overview of the comments received regarding Chapter 96, Water Quality Standards Implementation. Chapter 96 will also be on the agenda for the May meeting as final rulemaking and will be on the EQB agenda in early summer.

### Chapter 95

Dana Aunkst (<u>daunkst@state.pa.us</u>), Bureau of Water Standards and Facility Regulation and Richard Morrison (<u>rimorrison@state.pa.us</u>), Bureau of Regulatory Counsel, discussed and answered questions regarding the proposed changes to Chapter 95,

Wastewater Treatment Requirements, and requested a formal record of the WRAC's recommendations. Extensive discussion was held on various areas, specifically clarification on the watershed approach, the impacts on the conventional oil and gas industry and the recycling mandate for oil and gas wastewaters. The Department agreed that further discussion on the regulation was necessary and that it would consider making changes to the regulation based on the comments collected at WRAC. Further, the Department agreed to meet with individual stakeholders to discuss concerns.

The following motion was passed on majority:

WRAC appreciates all of the department's efforts to respond to our comments and improve the regulation. WRAC believes that the current draft of the regulation is substantially improved over the draft we reviewed in July of 2009, and we understand that additional improvements will be made based on our comments today. Although some of the individual WRAC members continue to have significant concerns about the regulation and whether it should proceed without an advance notice of final rulemaking, in light of the progress and efforts made to date and in light of the department's desire to proceed with the regulation, the consensus of the Committee is that the regulation should proceed for final consideration by the EQB.

### Chapter 92

Tom Starosta (tstarosta@dep.state.pa.us), Water Standards and Facility Regulation, presented an overview of the comments received regarding Chapter 92a, National Pollutant Discharge Elimination System Permitting, Monitoring and Compliance. Chapter 92a will also be on the agenda for the May meeting as final rulemaking and will be on the EQB agenda in July.
