NEW REGULATORY RADON FEE INCREASES EFFECTIVE OCTOBER 21, 2017

Certified Mitigation Individuals

Effective October 21, 2017, you are required to quarterly submit the following:

- A \$50 fee for each mitigation system installed or passive system activated by either you or any of your DEP-listed firm employees in that quarter. (Make all checks/money orders payable to *Commonwealth of Pennsylvania*.) **The first payment will be due for the 4th Quarter (Q4 of 2017) and this quarter only will begin on October 21, 2017 and end on December 31, 2017.** All other quarters are defined as follows:
 - 1st Quarter (Q1)** January 1 through March 31
 - 2nd Quarter (Q2)** April 1 through June 30
 - 3rd Quarter (Q3)** July 1 through September 30
 - 4th Quarter (Q4)** October 1 through December 31
- The attached *PA DEP Radon Mitigation Active System Fee Form* must be completed and included with every payment.

All payments must be received by the Department no later than 10 business days after the end of each quarter.

Radon Certification Applications

Both renewal and initial applications postmarked on or after October 21, 2017 shall submit fees in accordance with the following fee schedule:

Radon Certification Fee Schedule

Testing Individual	\$525
Testing Employee	\$150 (the 1 st employee is no longer free)
Testing Firm	\$1,050
Mitigation Individual	\$450
Mitigation Firm	\$1,050
Laboratory Individual	\$600
Laboratory Firm	\$1,125
Primary Testing Device Listing	\$150
Late Application Renewal	\$150
Mitigation System	\$50** (for each mitigation system installed or activated)

**Any mitigation individual who installs or who is in responsible charge of employees who install an active radon mitigation system in this commonwealth or who activates or who is in responsible charge of employees who activate a passive radon mitigation system in this commonwealth shall submit to the Department the radon mitigation system fee as specified in this appendix along with a Department-approved radon mitigation system fee form. The fee for each radon mitigation system installed or activated must be received by the Department no later than 10 business days after the end of the quarter in which the installation or activation was performed. The Department will waive the radon mitigation system fee for a local government employee or school employee who installs an active radon mitigation system in a school or local government building or activates a passive radon mitigation system in a school or local government building if the employee installs or activates the system pursuant to his official duties and the employee is not compensated for this service except through the employee's salary.
