## **NOTICE OF PUBLIC HEARING**

The Pennsylvania Department of Environmental Protection (DEP) will host a public hearing to obtain public comments regarding PA Waste, LLC's municipal waste application for a permit to construct the proposed Camp Hope Run Landfill in Boggs Township, Clearfield County, PA. The hearing will be held Monday, July 23, 2018, from 6:30 p.m. until 9:00 p.m. at the Florian Banquet Center, 321 Mill Road, Clearfield, PA. Doors will open at 6:00 p.m.

The proposed site is located on a 2,000-acre parcel approximately seven miles southeast of Clearfield located on the west side of Crooked Sewer Road. Approximately 217 acres is proposed to be used for a lined disposal area, with additional acreage used for support operations, for a total permitted area of 845 acres. If granted, the landfill would provide approximately 37 million cubic yards of waste disposal capacity and would potentially operate for 21 years at the acceptance rate of 5,000 tons per day.

Individuals may present up to five (5) minutes of oral testimony at the hearing. Comments must address the permit application submitted to DEP in 2017. Relinquishing of time to other speakers is prohibited. The testimony will be recorded by a court reporter and transcribed into a written document.

Those wishing to present comments at the hearing should register in advance with DEP by contacting Megan Lehman at meglehman@pa.gov or 570.327.3659, no later than 4:00 p.m. on July 20, 2018. Time permitting, those who did not register in advance but who register onsite prior to the start of the hearing will also be given the opportunity to testify. Individuals will be called to testify in the order they registered. The hearing may conclude earlier if all testifiers in attendance have spoken prior to the designated end time.

Written comments of any length may also be submitted to DEP by 4:00 p.m. on August 3, 2018. All relevant comments, oral and written, that are submitted by the deadline will be given equal consideration by DEP during its review of the permit application. DEP will create a written response to all relevant comments provided at the hearing and in writing by the deadline.
