Johnson, Mirmiran & Thompson (JMT) is pleased to submit the Erosion and Sediment Control General Permit for the Tilghman Lateral- Phase 2B. This phase encompasses a segment that runs primarily through Ridge Rd (SR 3006), West 2nd Street (SR291), Flower Street and Delaware Avenue. This phase spans through three municipalities: Lower Chichester Township, Borough of Trainer and City of Chester. The limits of work are from the Transco Meter Station (included in Phase 1 and 2A) to the Tilghman Meter Station. The scope of work includes installation of a 16" pipeline using open cut trenching and horizontal directional drill (HDD). Please note that Adelphia Gateway Project LLC- Phase 1 permit application and supporting documentation included Phase 2B in DRAFT format and it was included in the project area and total project disturbance.
