The purpose of this municipal notice is to inform you that Elcon Recycling Services, LLC will be applying for the following permit coverage(s) from the Pennsylvania Department of Environmental Protection (PA DEP): PA DEP Individual NPDES Permit.

Acts 67, 68 and 127 of 2000, which amended the Municipalities Planning Code (MPC) to direct State agencies to consider Comprehensive Plans and Zoning Ordinances when reviewing applications for permitting of facilities or infrastructure, and specify that State agencies may rely upon Comprehensive Plans and Zoning Ordinances under certain conditions as described in Section 619.2 and 1105 of the MPC.
