I would like to request an extension on the fly over we have planned for the end of September. Crews Surveying was planning to do their fly over next week on Monday & Tuesday September 24<sup>th</sup> & 25<sup>th</sup>. Because of the extremely wet weather we have experience this year the ground remains very wet. The ground is far to wet for us to use our equipment we use in the quarry. The haul trucks are too big and will sink into the ground due to the ground is too soft. In addition our loaders cannot safely move the fill over the walls. Track vehicles are needed to do this. In order to continue with the reclamation process we have contracted Mark Hendrickson Excavating to do the work at this time. He has smaller dump trucks to be able to haul the fill and a track bull dozer to push the fill. Hendrickson Excavation has spent Thursday and Friday this week preparing the road and hill with stone and fill so his equipment can safely travel on and start the work. Plans are for Hendrickson Excavating to do the work all next week working on areas #1 & #2 and the stream inlet channel.

I would like this work to be done next week and then have the fly over so we can capture this work on the fly over. Hopefully further dry weather will occur and we can get back in the stream to finish further work there.

Here is the proposed schedule :

1. Hendrickson Excavating to perform reclamation work Mon – Fri Sept 24<sup>th</sup> -28<sup>th</sup>
2. Crews will plan to do the fly over Tuesday Oct 2<sup>nd</sup>
3. Fly over data to be provided to EarthRes on Oct 8<sup>th</sup>?
4. EarthRes needs approximately one week to complete the volume calcs and provides submittals to DEP around October 15<sup>th</sup>

If all works as outlined above, NHCS would need an extension until October 15<sup>th</sup> to Oct 22<sup>nd</sup> range.
