On behalf of New Hope Crushed Stone & Lime Company (NHCS), EarthRes Group, Inc. (EarthRes) is providing the monthly Corrective Action Plan (CAP) update in response to Compliance Order No. 16-5-032-N issued by the Department and dated August 26, 2016. This letter and attached table details activities completed by NHCS during the month of May 2017.

There were 22 working days in May. Rain was observed on approximately 14 days (9 work days) throughout the month, with significant precipitation occurring on May 5<sup>th</sup> (0.99"), 13<sup>th</sup> (1.82"), 22<sup>nd</sup> (0.45"), 25<sup>th</sup> (1.3"), and between the 28<sup>th</sup> and 31<sup>st</sup> (0.68").

Reclamation was completed on the East and Southeast wall. Reclamation work included west wall access road construction and widening of the haul road for staging of reclamation fill. When possible, work was completed during inclement weather, and crews worked on separate reclamation projects, as indicated on the attached table. Stream reclamation was not completed in May due to the lack of current west wall access and wet weather conditions. However, stream construction meetings were held in May with the Department and NHCS' consultant and contractor to assure timely work startup when favorable weather conditions return.

## Conclusion

NHCS completed significant work towards reclamation in May as indicated on the attached table. Work efforts on stream restoration and/or reclamation will continue in the coming months as scheduled, noting potential limitations due to weather, safety and other factors as indicated in the September 23, 2016 CAP and November 4, 2016 CAP update filed with the Department.
