Dear Mr. Sewell:

Your NPDES permit amendment is enclosed. Changes to the permit made as minor modifications under 40 CFR § 122.63(e) are as follows:

- Authorization to discharge from Interim Outfalls 007, 008, 009, 010, and 013 is removed from the permit by setting the end date of the interim compliance period to the date of issuance of Amendment No. 2.
- Authorization to discharge from Final Outfalls 007, 008, 009, 010, and 013 begins as of the date of issuance of Amendment No. 2.
- Outfalls 114, 020, and 813 and Interim Monitoring Point 113 are removed from the permit.

Please read the permit carefully. The permit expires on the date identified on page 1 of the permit. A renewal application must be submitted to this office 180 days prior to the permit expiration date, if a discharge is expected to continue past the expiration date of the permit.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board), pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:

Appeals must be filed with the Board within 30 days of receipt of notice of this action unless the appropriate statute provides a different time. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.

IF YOU WANT TO CHALLENGE THIS ACTION, YOUR APPEAL MUST BE FILED WITH AND RECEIVED BY THE BOARD WITHIN 30 DAYS OF RECEIPT OF NOTICE OF THIS ACTION.
