Have you ever wondered why PA DEP strongly supports optimization of surface water treatment plants through the Filter Plant Performance and Partnership for Safe Water Programs?

Optimization programs such as these are important to Pennsylvanians and the state's surface water suppliers for the following reasons:

- **Population Impact**: Over 8.4 million people and numerous tourists receive some or all of their drinking water from the Commonwealth's filter plants.
- **Disease Prevention**: A treatment breakdown at a filter plant presents a widespread acute health threat from a waterborne disease outbreak. A disease outbreak can have a devastating impact on a community. Disease prevention saves millions of dollars in expenses that businesses, homeowners, local government and state government would incur in response to an outbreak.
- **Economy and Essential Services**: Filter plants serve drinking water to large metropolitan areas and small rural communities and thus are a vital part of local infrastructure; they represent an essential service to many businesses; and they provide basic fire protection for homeowners and businesses.
- **Technical Assistance**: Filter plants involve some of the most complex regulations and treatment processes. Optimization programs, such as the PfSW and FPPE helps suppliers in overcoming numerous on-going compliance challenges.

PADEP has developed a new website which contains detailed information about the Filter Plant Performance Evaluation process. By completing Phase III of the PfSW program the City of Lancaster Conestoga WTP has absolutely improved overall facility operation. Turbidity performance is irrefutable proof of improved operations. The self-assessment phase promoted better communications that resulted in improvements in all phases of operations. Using the self-assessment guidelines, we discovered our operators had developed individual procedures that were not documented. By discussing the different approaches, the operators were able to identify and adopt the best methods.

The importance of formal procedures is now emphasized and updated on a regular schedule. Yes, an in-house self-assessment is worth the effort in numerous ways. Having all sections and staffing levels participating in the assessment provided a compressive evaluation of the system. With the partnership's clearly defined performance goals, each section was able to focus on their interaction towards that goal. The degree of interdependence was not realized until the assessment was completed. We found the procedure to be a valuable training tool for our operators, supervisor, and support staff.
