

## Underground Storage Tank Class A and Class B Operator Training

### I. PUBLIC APPROVED TRAINING COURSES FOR CLASS A AND CLASS B OPERATORS

The following courses have current approval from the Pennsylvania Department of Environmental Protection (DEP) to provide training to prospective Class A and/or Class B Operators of underground storage tank (UST) systems and facilities; pursuant to 25 Pa. Code §§ 245.141 and 245.436.

There are 3 types of courses available:

- Online –** These courses are self-directed online/automated training courses.
- Classroom –** These courses are routinely scheduled and hosted by the training provider.
- The class may have individuals from multiple companies.
  - These courses often include the instructor reviewing details specific to your facility.
  - These may include instructor led courses conducted over the internet.
- On-Site -** These courses are conducted at your facility or company's provided training location.

**Class A & B Operator training certificates do not expire.**
