Development of Standard Protocol for Small Boilers under General Permit 1 (GP-1) – Matt Bomberger, Air Quality Specialist in Source Testing, will announce plans to create a standard protocol for small boilers covered under General Permit 1 (GP-1). Emissions Guidelines (EGs) for Greenhouse Gas (GHG) Emissions From Existing Crude Oil & Natural Gas Facilities (40 CFR Part 60 Subpart OOOOc) – Panna Chibber, of DEP's Bureau of Air Quality Technical Support Section will discuss EPA's new requirements under 40 CFR part 60 subpart OOOOc. Subpart OOOOc requires states to set new requirements for oil and natural gas operations to reduce greenhouse gas emissions. Pennsylvania has the option to either adopt the federal standards or develop standards that are no less stringent than the federal standards. Streamling Permits for Economic Expansion and Development (SPEED) Program – The SPEED program is designed for the expedited review of permit applications by qualified professionals (QP). For Air Quality, applicants may request that state-only plan approval applications be reviewed by QPs under the SPEED program. Applicants are responsible for QP costs.
