An asterisk typically indicates when a field is required. We recommend, if this field is not required that you remove the asterisk."  If the user answers NO and there is no asterisk; then there is no follow-up.  The above rules can occur when the user answers yes or no to the question; they could also occur when the user clicks save but that is not necessary. this will not prevent the user from doing anything; and the message does not need to immediately change if the individual edits the control label.
