Climate Pollution Reduction Grants Outreach: 8 in-person workshops with XX participants, 5 virtual sessions with XX participants

AFIG Helps Pennsylvania Local Governments Electrify Their Fleets – Allegheny County and Delaware County, along with Warrington Township in Bucks County, recently completed the purchase of electric vehicles for their fleets.

- 14,795 gallons of gasoline displaced, reduction of 131 metric tons of CO₂ per year
- cost savings of \$42,541 each year.
- The EVs in Allegheny County's fleet are displacing an estimated 5,890 gallons of gasoline per year, and saving them in fuels costs of approximately \$21,282 per year.

April 24: EPO and PennDOT will be hosting a Drive Electric Pennsylvania Coalition meeting where attendees will be provided with electric vehicle and charging related incentive updates, and updates on construction of National Electric Vehicle Infrastructure (NEVI)-funded chargers.
