Purpose: Stabilize the local township road.

Description: Normalville South is a reclamation project of a dangerous slide

area, AMLF No. 0430-03 (DS). The inquiry site is Township Road 836, Hawkins Hollow Road. The problem is a landslide affecting the stability of the out slope lane. The Township has repeatedly placed stone at the scrap of the slide. The slide is caused by the lubricating effects of mine drainage water from an abandoned underground mine in the Lower Kittanning Coal Seam and the naturally steep topography. AMD was present in the slide area and also in the road open channel drainage ditch on the in slope lane of the roadway. Two collapsed drift entries are located up slope of the slide area. During the spring of 2007 the slide moved 12 inches down causing a more serious hazard to local motorists and increasing the worth of the project to a High Worth. There was a BD project for materials (2A stone) only to the Township to keep

the road open.


