Summary

As of July 2008, cost estimates indicate that the annual O&M cost for the primacy ABS bond forfeiture discharges is about \$1.35 Million. The capital cost to construct the needed facilities is about \$2.07 Million. The total estimated present value of the recapitalization costs is \$5.6 Million. With the pay-as-you go approach, the present value of the recapitalization costs has limited meaning. Therefore a spreadsheet of the estimated recapitalization cost payouts has been prepared. The total amount of remaining collected bond for these sites to be transferred into the ABS Legacy Sites Trust Account is \$4.9 Million.
