2019 AML Reclamation Grading Costs

- 4 reclamation projects with 2,070,030 total cubic yards
- Cost per cubic yard ranged from \$0.80 to \$2.00
- low bid average at \$0.88
- Current 2017 2019 low bid weighted average at \$0.79 for 500 ft. or less



Haulage AML Reclamation Grading Refuse Disposal and Underground

- Selected haulage low bid reclamation projects with 8,110,097 total cubic yards
- Cost per cubic yard ranged from \$1.18 to \$3.42
- low bid average at \$2.58 for 1,000 ft up to 1 mile



2019 AML Reclamation Revegetation

- 5 reclamation projects with 262.3 acres revegetation
- Cost per acre of the low bid ranged from \$847.66 to \$2,574.66
- 3 year weighted average of low bid was \$1,830.07



2019 AML Reclamation Mulch, Seed Bed Preparation and Seed

- Mulch cost per acre low bid weighted average \$918.36.
- 3 year weighted average of Mulch cost is \$892.14.
- Seed Bed Prep cost per acre low bid weighted average \$220.06
- 3 year weighted average of Seed Bed Prep is \$218.56.
- Seed cost per acre of low bid weighed average \$371.16.
- 3 year weighted average of Seed is \$379.74.
