A Message from MRAB Chairman David Osikowicz

On behalf of the Mining and Reclamation Advisory Board (MRAB) members, I am pleased to present for your review the Board's Annual Report, documenting the Board's activities from July 2022 through June 2023. The Board continues to address environmental problems related to past coal mining practices and to assist the Department in ensuring that current industry practices represent an environmentally responsible approach to mining. This report fulfills the statutory obligations of the Surface Mining Conservation and Reclamation Act (SMCRA).

The Board holds four full board meetings per year, as outlined in the by-laws. For the 2022-2023 reporting period, full Board meetings were held on July 21, 2022; October 13, 2022; January 12, 2023; and April 13, 2023. The Board's Reclamation Committee met on November 16, 2022 to discuss bond rate guidelines.

During the time frame of this report, Pennsylvania Department of Environmental Protection (PA DEP) staff provided the Board with regular updates on the status of Bond Rate Guidelines, Bureau of Abandoned Mine Reclamation (BAMR) Projects, Bureau of District Mining Operations (BDMO) activities and, the Alternative Bonding System (ABS) Legacy Sites.

The Board will continue to provide advice and technical input to the Department regarding expenditures and program administration of Abandoned Mine Lands (AML) Title IV monies, proposed regulatory rulemaking issues including Act 95, permit fees, financial guarantee and OSM issues, and other environmental issues as they arise.

The Board recognizes the dedication and support of all Board members and alternates and the ongoing contributions by both PA DEP staff and Board members. Furthermore, the Board remains highly committed to advising and working with the department in carrying out its mission, evaluating the rights and responsibilities of industry, and making responsible, calculated recommendations for the citizens of the Commonwealth.

Introduction

The Mining and Reclamation Advisory Board (MRAB) was created in 1984 by Act 181 of the Pennsylvania General Assembly, which amended the Surface Mining Conservation and Reclamation Act (SMCRA). The Board's purpose is to assist the Secretary of the Pennsylvania Department of Environmental Protection (PA DEP, DEP or Department – per the Bureau of Mining Programs (BMP)) in expending reclamation funds for the purposes provided by SMCRA and to advise the Secretary on all matters pertaining to mining and reclamation. The advisory role of the Board also covers Title IV of SMCRA, which relates to abandoned mine land reclamation issues.

The Board is comprised of the following members:

- Two licensed bituminous surface mine operators;
- One licensed anthracite surface mine operator;
- Four public members of the Citizens Advisory Council, elected by the Council;
- One anthracite or one bituminous licensed professional engineer;
- One county conservation district representative, appointed by the Pennsylvania State Conservation Commission;
- One majority party state senator, appointed by the president pro tempore of the Senate;
- One minority party state senator, appointed by the president pro tempore of the Senate;
- One majority party state representative, appointed by the speaker of the House of Representatives; and
- One minority party state representative, appointed by the speaker of the House of Representatives.

The Board operates under bylaws adopted in January 1989 and amended in October 1993 and December 1996. The bylaws establish a committee structure and other operational procedures, including a minimum of four meetings per year, held in January, April, July and October, as required by SMCRA. *The bylaws current for the time period covered by this report are found in Appendix A.*

The Board's Committees

- **Annual Report Committee**

As mandated by Section 18(g)(5) of SMCRA, "The Board shall prepare an annual report on its activities and submit the report to the Senate Environmental Resources and Energy Committee and the House Conservation Committee." Throughout the reporting period, the committee compiles and summarizes information for inclusion in the Annual Report.

At the October 22, 1999 MRAB quarterly meeting, the Board voted unanimously to change the name to the Reclamation Committee to reflect the committee's ongoing work. The committee addresses reclamation issues, initiatives and activities.

FULL BOARD

SMCRA mandates that the MRAB meet four times per year. Throughout the reporting period, the full Board met four times. The following sections provide a summary of the activities of the full Board. For a complete list of meeting dates and locations, see **Appendix D**. 2022-2023 MAIN AGENDA TOPICS (Presented Alphabetically)

Annual Production Reports

This reporting process will receive updates for next year.

Applications

PA DEP BMP provided the Board with a detailed breakdown of application data at each meeting, including the number of applications by each District Mining Office (DMO) and revision and application type. All figures are available through the MRAB meeting materials under the MRAB on the DEP website.

Application Fee Revenues

PA DEP BMP provided revenue figures for the Surface Mining Conservation and Reclamation Act (SMCRA) and Clean Water Fund (CWF) for the fiscal year 2021-2022 (ending June 30, 2022) at the July board meeting. PA DEP BMP also provided revenue figures for these funds through August 31, 2022 at the October meeting. At the January 12, 2023 meeting, Mr. Greenfield provided revenue figures for the Surface Mining Conservation and Reclamation Act (SMCRA) and Clean Water Fund (CWF) for fiscal year 2022-2023 through November 30, 2022.

Bonding and Bond Rate Guidelines

At the January 2023 meeting, PA DEP BMP provided the Board with the preliminary Coal Bond Rates for 2023. Several questions were asked on how rates were determined and how the pandemic affected the bond rate numbers. The 2023 rates went into effect on April 1, 2023.

Bureau of Abandoned Mines Reclamation (BAMR) Projects/Status Report

Updates on reclamation projects were supplied by PA DEP's Bureau of Abandoned Mine Reclamation (BAMR). In 2022, there were 128 projects completed, reclaiming 430.4 acres, at a cost of about \$50.9 million. For 2023, there are 38 projects planned that will reclaim 877.9 acres, at a cost of about \$108.1 million. Finally, there are 71 future project awards in the design phase that will reclaim 1,639 acres, at a cost of about \$146.5 million. There were 50 emergency projects at \$2.1 million cost in 2021; for 2022 there were 86 emergency projects at \$3.7 million cost. Mr. Webb noted the Omnibus Bill with the Safeguarding Treatment for the Restoration of Ecosystems from Abandoned Mines (STREAM) Act to amend the recently-passed Bipartisan Infrastructure Law (BIL), add explained how up to 30% of the \$244.9 million in allocated funds can

be used for Acid Mine Drainage, Mine Subsidence and Mine Fires after the next 20 years. Mr. Webb indicated that questions raised on specifics of funds and their bonding requirements require further discussion with the Federal Office of Surface Mining (OSM), which will be upcoming. Mr. Webb also noted that the 2022 Grant program closed Friday, January 13, 2023. The 2023 Grant program will open March 2023 with 3 rounds occurring through the full year. In 2023 so far, there have been 31 Abandoned Mine Land (AML) Fund emergencies (there are about 80 per year, on average). Many of these emergencies were related to vertical openings (mine subsidence) and, contract projects involving homes and buildings, mine gases and mine blowouts.

Funding Status:

- Bipartisan Infrastructure Law (BIL): The first annual award of \$244.9 million has been provided to Pennsylvania (under the BIL, there will be 15 such annual awards). So far, 6 projects have been awarded, at a total of \$4.7 million, and once 1 additional project is awarded, a total of \$5.3 million of BIL monies will be obligated for projects. The main challenge for some projects involves getting property owner consent.
- Stream Act: The existing BIL Fiscal Year (FY) 2022 grant has been amended and submitted to OSM on March 23, 2023 to allow for 30% of the monies to go into the newly-established State Stream Act Set-Aside Account. OSM is currently reviewing this grant amendment.
- Notice of Funding for 2023 AML Fee-Based Grant: Pennsylvania will be able to apply for \$21 million in funds from this grant.
- Abandoned Mine Land Economic Revitalization (AMLER): In the proposed 2024 Presidential budget, \$28.9 million is being proposed for the AMLER program in Pennsylvania. In 2023, Pennsylvania received the notice of funding opportunity of \$29.34 million for this program and, for 2022 and 2021, there are still AMLER funds available (\$18.1 million and \$15.3 million, respectively). The new AML/Acid Mine Drainage (AMD) grant program has reviewed 29 applications; some have been recommended for grant awards and, some have not. Some of the approved applications may use 2021 and 2022 AMLER funding and, BIL funding. Other related matters mentioned included: 1) the status of unspent AMLER funds (projects are in the queue now, but more details are needed as to how the funds will be spent); and 2) improving the review and public notices for potential future AML sites that could use BIL monies.

Legislation relating to program funding has been introduced at both the State and Federal levels. Further information will be provided as matters continue to develop.

Coal Refuse Disposal

The final rulemaking for Coal Refuse Disposal was presented to the Environmental Quality Board (EBQ) at its meeting on July 12, 2022. The Independent Regulatory Review Commission (IRRC) approved the final Coal Refuse Disposal Revisions rule on July 21, 2022. The final rule was published in the *Pennsylvania Bulletin* on September 10, 2022, at 52 Pa.B. 5804.

Coal Mining Renewal Application

At the October 13, 2022 meeting, PA DEP BMP provided a status report on the renewal application draft. The PA Coal Alliance (PCA) provided comments regarding underground and coal refuse disposal operations in western PA. There were no additional comments from surface operators. The newly reformatted mining permit renewal form is currently available on the DEP website.

Deliverables

No deliverables were requested during the four meetings.

District Mining Offices (DMOs) Update

PA DEP provided the Board with periodic updates on the activities of the District Mining Offices (DMOs) including vacancies, workloads, processing of permit applications, management of overdue permit application approvals). The United States Environmental Protection Agency (US EPA) will look at selected DMO mining permits (up to 30 of these) from one or two DMOs. Elements that will be reviewed include: 1) documented violations; 2) enforcement; 3) penalty assessment; 4) inspections; and, 5) data input. The US EPA will begin its review in May or June of 2023. National Pollutant Discharge Elimination System (NPDES) Workload Assessment: The United States Environmental Protection Agency (US EPA) is planning a NPDES workload assessment study. The assessment will evaluate State program resources such as staffing funding, and technical capacity of the programs. The study is expected to start in May of 2023.

E-Initiatives

PA DEP provided the Board with updates on e-Initiatives, including Notice of Intent to Explore (NOI) e-permits, electronic discharge monitoring reports (eDMRs), mobile inspections and the distribution of inspection reports. The pre-application for Bituminous Surface Mining Permit (SMP) was recently added.

Engineering Manual

The Engineering Work Group had its first meeting in November 2022 and is currently looking for input from both MRAB and the Aggregate Advisory Board's respective Regulation, Legislation and Technical (RLT) Committees and, external consultants. The Work Group will be holding regular meetings going forward to develop additional tools that will replace the old Engineering Manual.

Field Trip

On October 12, 2022 (prior to its October 13, 2022 meeting), the Board held a field trip to tour the DEP BAMR River Street Facility in Plains, PA and visited the Swoyersville Culm Bank Project site.

GP-104

Looking forward, the GP-104 is up for renewal in March 2026, and ongoing system improvements to permitting are being made. BMP is transitioning the Notice of Intent for coverage of this National Pollution Discharge Elimination System (NPDES) general permit (Stormwater only) to the e-permitting system and will, concurrently, make sure all operators are registered with the eDMR program for mandated electronic submissions.

Incidental Coal Application

The Incidental Coal application has been modernized for ease of use and is available on the e-Library. BMP is also continuing the process for updating the renewals application and will update the Board as it becomes available.

Land Reclamation Financial Guarantees (LRFG)

PA DEP BMP provided details on the increase of LRFG permits and amount underwritten. The total underwritten amount as of September 2022 was \$46.6 million. The Board was shown the current information for the LRFG Account including operators at the operator limit of \$3 million (currently 1 Bituminous and 2 Anthracite operators).

Liners and Caps Technical Guidance Document (TGD)

The Liners and Caps Technical Guidance Document (TGD) was final as of May 28, 2022.

National Pollutant Discharge Elimination System (NPDES) Permitting

The United States Environmental Protection Agency (US EPA) meets regularly with BMP to discuss topics including Total Maximum Daily Loads (TMDLs) and effluent characterization.

Non-Mining Related Activities Standard Operating Procedures (SOP)

The Non-mining related activities SOP is still in the development stage.

Postmining Discharge Operation and Maintenance Bonds & Financial Trust Agreements

PA DEP BMP provided the Board with regular updates regarding the status of postmining discharge operation and maintenance bonds being held by the Department to treat noncompliant discharges. As an alternative to these bonds, operators have also established financial trust agreements to assure the financial requirements of long-term water treatment for postmining discharges can be achieved.

Reclamation Fee Operation and Maintenance (O & M) Trust Account

PA DEP BMP provided regular updates on the status of the Reclamation Fee Account, in terms of the following: 1) coal civil penalties collected and interest earned; 2) additional revenue transactions; and 3) LRFG premiums and interest.

Reclamation Fee Report

PA DEP BMP presented the Board with the updated Draft Fee Report. It received no public comments. The fee will continue to be \$100.00 per acre for 2023. The coal civil penalties collected and interest from the Land Reclamation Financial Guarantees (LRFG) account from 2021 will be moved to the Reclamation Fee Operation and Maintenance (O&M) Trust Account in the Fall of 2023.

Revenues

PA DEP provided regular status reports on application fee revenues from two main sources: 1) the Surface Mining Conservation and Reclamation Act (SMCRA); and 2) the Clean Water Fund (CWF).

Technical Items

An updated State Water Plan was sent to Board members for their review.

PA DEP BMP is attempting to standardize the format of five modules to simplify the application process and ease the transition of the applications into e-permitting formats.

Water Supply Replacement TGDs

The Water Supply Technical Guidance Documents (TGDs) are being updated in response to the Water Supply Regulation change.

Appendix A

BYLAWS OF THE MINING AND RECLAMATION ADVISORY BOARD

As Amended December 12, 1996

ARTICLE I Authorization

The Mining and Reclamation Advisory Board is authorized and organized pursuant to Section 18(g) of the Pennsylvania Surface Mining Conservation and Reclamation Act (Act 181 of 1984) as amended by Act 173 of 1992.

ARTICLE II Purpose

The advisory Board is charged to assist the secretary to expend the funds for the purposes provided by this act and to advise the secretary on all matters pertaining to surface coal mining and reclamation which shall include, but not be limited to, experimental practices, alternate methods of backfilling, selection of reclamation projects, alternate reclamation methods, obligations for pre-existing pollution liability, alteration of reclamation loans, reclamation fees and bonding rates and methods.

ARTICLE III Membership

The Board shall be comprised of three coal operators, two of whom shall be licensed bituminous surface mine operators and one of whom shall be a licensed anthracite surface mine operator; four public members from the Citizens Advisory Council, who shall be appointed by the council; two members, one from the Anthracite and Bituminous Licensed Professional Engineers, and one from the County Conservation Districts, who shall be appointed by the State Conservation District Commission; four members of the General Assembly, two from the Senate, one member from the majority party and one member from the minority party, who shall be appointed by the president pro tempore; and two from the House of Representatives, one from the majority party and one from the minority party, who shall be appointed by the speaker of the House of Representatives.

- A. Board members shall designate an alternate. The chairperson shall be notified, in writing, of such alternate.
- B. The Board may recommend to the appointing authority removal of any member not attending, or not represented by a designee, at two Board meetings in a year.

ARTICLE IV

Voting

Members, or designated alternates, shall be entitled to one vote, in person, on all matters that shall come before the Board. No voting shall be done without a quorum, unless otherwise indicated in these bylaws. A majority of the membership of the Board shall constitute a quorum.

ARTICLE V

Officers

The officers of the Board shall be a chairperson and a vice-chairperson.

The chairperson and vice-chairperson shall be elected from the membership of the Board, as defined in the Pennsylvania Surface Mining Conservation and Reclamation Act, as amended, and may not be the secretary of the Department of Environmental Protection, or his designee. They shall hold office for a term of one year, or until a successor is elected.

It shall be the duty of the chairperson to preside at all meetings of the Board, call special meetings, prepare and distribute the meeting agenda and perform such other duties as pertain to the office.

It shall be the duty of the vice-chairperson to perform the duties of the chairperson in his/her absence.

ARTICLE VI

Administration

Administrative and clerical duties shall be performed by the Office of Mineral Resources Management, Department of Environmental Protection. A department staff person shall function as a recording and corresponding secretary. Included among these administrative duties shall be:

- A. To give timely notice of meetings of the Board and committees.
- B. To record full Board and committee meeting minutes and keep a permanent file. Board and committee meeting minutes shall be distributed to the full membership. Minutes should be reviewed by the chairperson or vice-chairperson prior to distribution.
- C. To conduct both outgoing and incoming correspondence and maintain a permanent file of such correspondence, and
- D. To perform such other duties as may be requested by the Board, including, but not limited to, travel arrangements, conference calls, etc.

In addition, staff representatives from the Office of Mineral Resources Management shall serve as staff liaison to the Board.

ARTICLE VII
Committees

The Board may establish committees to assist in performing its advisory duties.

- A. Committees shall be established by a majority vote of those members attending a regular or special meeting of the Board.
- B. The Board chairperson shall appoint committee members. The committee chairperson shall be selected by its members. The committee chairperson will be responsible for calling committee meetings, requesting needed assistance from DEP, and reporting to the Board, and shall receive necessary administrative and clerical support from DEP.
- C. Each committee shall develop and adopt a statement of purpose or objective of the committee at a meeting of that committee after its creation.
- D. The chairperson of the Board shall appoint a committee to prepare the Annual Report, as mandated by Section 18(g) of the Pennsylvania Surface Mining Conservation and Reclamation Act.
- E. A listing of the committees and their statements of purpose shall be maintained as an appendix to these bylaws. Changes to the appendix shall not constitute a change to the bylaws.

ARTICLE VIII
Meetings

The Board shall meet on the first Thursday of the months of January and July and the fourth Thursday of the months of April and October, unless changed by a majority of the members. Alternate meeting dates and special meetings shall be called by the chairperson, in consultation with the vice-chairperson. Committee meetings shall be called by committee chairpersons, who shall also notify the full Board.

ARTICLE IX
Participation by Non-Board Members

- A. Formal Presentation

Any person may ask the Board for time on the formal agenda to present policy, regulatory or legislative concerns for the Board to consider. The request shall be made in writing to the chairperson and include a summary of the presentation. The chairperson shall determine the interest of the Board in the subject and decide if the presentation will be allowed during the formal agenda. Requests shall be submitted at least one month prior to a Board meeting.

B. Informal Discussion

At the discretion of the chairperson, any person present at the meeting shall be afforded the opportunity to speak to the Board or ask questions of Board members.

ARTICLE X
Amendments

The bylaws may be amended, repealed or suspended at any meeting of the Board by a two-thirds vote of the members of the Board, provided that written notice of such amendment, repeal or suspension shall have been sent to each member at least one week prior to said meeting.

ARTICLE XI
Board Representation

The Board shall act as a body in all matters before it and only the chairperson, or his or her designee, the vice-chairperson or the Board's designee shall speak on behalf of the Board.
