Dear Mr. Bangs, Mr. and Mrs. Nogee and Counsel,


On July 11, 2014, Mr. Bangs entered an Order scheduling a hearing on Hilcorp Energy Company's Application for Well Spacing Units in the Pulaski Accumulation for September 16 and 17, 2014. Unfortunately, Hilcorp's expert witness, Dr. Terry Engelder, has an unavoidable scheduling conflict with the dates set for the hearing. His participation, we feel, is essential. Therefore, Hilcorp respectfully requests the cooperation of all parties to this matter in determining alternative dates for the hearing that would accommodate the schedules of the hearing participants, taking into account the availability of the Assembly Room at the Albert P. Gettings Government Center Annex of the Lawrence County Government Center, or an alternative venue if necessary.
