

HDD PA-DE-0008.0000-RD (Slitting Mill Road)

Given the design, the threat of inadvertent return has been reduced to the maximum extent practicable and in this case that threat is considered to be low. Implementing this design, along with adherence to the Pennsylvania Pipeline Project Inadvertent Return Contingency Plan will ensure inadvertent impacts, if they were to occur, are also minimized to the maximum extent.

The drill will enter/exit 1302 feet northwest of Slitting Mill Road. The southwest entry/exit point is 76 feet southeast Slitting Mill Road. The drill will pass 13 feet under this road. Using the results of the geotechnical investigation, as well as several other data points, the entry/exit, angles, and depths have been configured to pass through the best substrates while maintaining pipe integrity (e.g., no large bends). The majority of the substrate that will be passed through is estimated to be silty sand, and clay.







20-INCH HORIZONTAL DIRECTIONAL DRILL SLITTING MILL RD PENNSYLVANIA PIPELINE PROJECT


