RE: Sunoco Pipeline L.P. Pennsylvania Pipeline Project
Floodplain/Stormwater management Program Consistency Request

Dear Ms. Batoon:

In accordance with the location map provided in your correspondence to the Lebanon County Commissioners, dated November 10, 2015, the following municipalities within Lebanon County will be impacted by the above referenced project – South Londonderry Township, South Annville Township, West Cornwall Township, Cornwall Borough, South Lebanon Township, and Heidelberg Township (west to east). It appears the specific watersheds affected by this project are the following – Spring Creek (South Londonderry Township), Quittapahilla Creek (South Annville Township, West Cornwall Township, Cornwall Borough, and South Lebanon Township), and Cocalico Creek (South Lebanon Township and Heidelberg Township). As indicated in your correspondence, Lebanon County has only two approved and adopted Act 167 Stormwater Management Plans for Cocalico Creek and Tulpehocken Creek. The Tulpehocken Creek Watershed is not impacted by this project.

Review of the Cocalico Creek Act 167 Stormwater Management Plan, of which South Lebanon Township and Heidelberg Township are included, it was found the above referenced project is consistent with the Stormwater Plan. Please be advised that those municipalities located in the Spring Creek and Quittapahilla Creek Watersheds – South Londonderry Township, South Annville Township, West Cornwall Township, and Cornwall Borough do not have approved Act 167 Stromwater Management Plans.

In regard to Floodplain Management, the Lebanon County Planning Department provides enforcement of the Floodplain Management regulations for the following municipalities — Cornwall Borough, South Annville Township, South Lebanon Township, and West Cornwall Township. Where applicable, the proposed activity for the above referenced project has been reviewed and is consistent with the FEMA Floodplain Management Programs effective in each of the above referenced municipalities. Input regarding consistency with Floodplain Management for Heidelberg and South Londonderry Townships should be obtained from those municipalities.
