Transcontinental Gas Pipe Line Company, LLC (Transco) is providing a response to the Incompleteness Notification received from the Pennsylvania Department of Environmental Protection (PADEP) dated June 26, 2025, for the Northeast Supply Enhancement Project (Project). The comment is outlined below:

***PADEP Comment:***

***1. “The Permit Fee Impact Summary Table in the ARIT and the Application Fee Worksheet appear to show inconsistent impact values. Please review and revise the application to ensure consistency. Note that all impact values must be rounded up to the nearest 0.1 acre, as required by the instructions in 3150-PM-BWEW0553. [25 Pa. Code §105.21(a)(1)].”***

***Transco Response:***

The Permit Fee Impact Summary Table in the Aquatic Resource Impact Table (ARIT) and the Application Fee Worksheet have been revised to include consistently reported impact values. All impact values have been rounded up to the nearest 0.1 acre in accordance with the instructions provided in DEP form 3150-PM-BWEW0553 and the requirements of 25 Pa. Code §105.21(a)(1).

The ARIT Permit Fee Impact Summary Table includes 0.91 acres of temporary impact and 4.18 acres of permanent impact. These values have been rounded up to 1.0 acres of temporary impact and 4.2 acres of permanent impact in the attached revised ARIT (Enclosure 1).

A revised Application Fee Worksheet is enclosed with this response (Enclosure 2). The corrected values are identified using **bold/italic** font. The updated worksheet reflects the rounded impact totals and corresponding fee calculations for a total of \$39,350.

The fee difference of \$4,400 will be submitted using Reference Number 324356 and PIN 880446, as provided in the incompleteness letter.

Since the submittal of the Chapter 105 application on June 13, 2025, Transco received the attached archaeological approval from the Pennsylvania State Historic Preservation Office (PA SHPO) dated June 16, 2025 (Enclosure 3). As noted in the PA SHPO summary submitted with the application, clearance for above-ground resources had already been obtained. This archaeological approval completes the SHPO review for the Project.

Transco appreciates the Department's assistance and expeditious review of this application. Transco looks forward to promptly providing any further information, as requested by the Department, to help facilitate the review of the application.
