Transcontinental Gas Pipe Line Company, LLC (Transco) is providing the response package associated with the Information Request provided on October 27, 2022 for the Regional Energy Access Expansion Project. The information requested has been uploaded via OnBase. Below is a summary of the requests and Transco's response to each comment.

1. In Requirement G-6, it appears that the bat restriction table is outdated. Please submit the most current bat restriction table. Also, please include the September 1, 2022 U.S. Fish and Wildlife Service (USFWS) clearance letter in the submitted document.

Requirement G-6 has been updated within both permit applications to include the 8/31/2022 USFWS Clearance Letter and associated bat restriction table.

2. In Requirement G-4 Privileged, a letter dated May 4, 2022 from the Pennsylvania Game Commission (PGC) references a March 15, 2022 summary. There is a bookmark prepared in the file, but no document is included. Please provide.

The March 15, 2022 correspondence letter is now included within the Requirement G-4 Privileged file for both applications. The referenced reports within the March 15, 2022 letter are included as part of the permit application already, however, are also included with this submission as a separate digital file.

Additionally, Requirement G-4 Public and Privileged files have been updated to include the April 15, 2022 letter previously not included from the PGC.

3. In Requirement H of Luzerne County, page 70 is a title page, not an impact drawing. Please provide the correct page 70.

Requirement H of the Luzerne County Permit Application has been updated to include the correct Sheet 70.
