

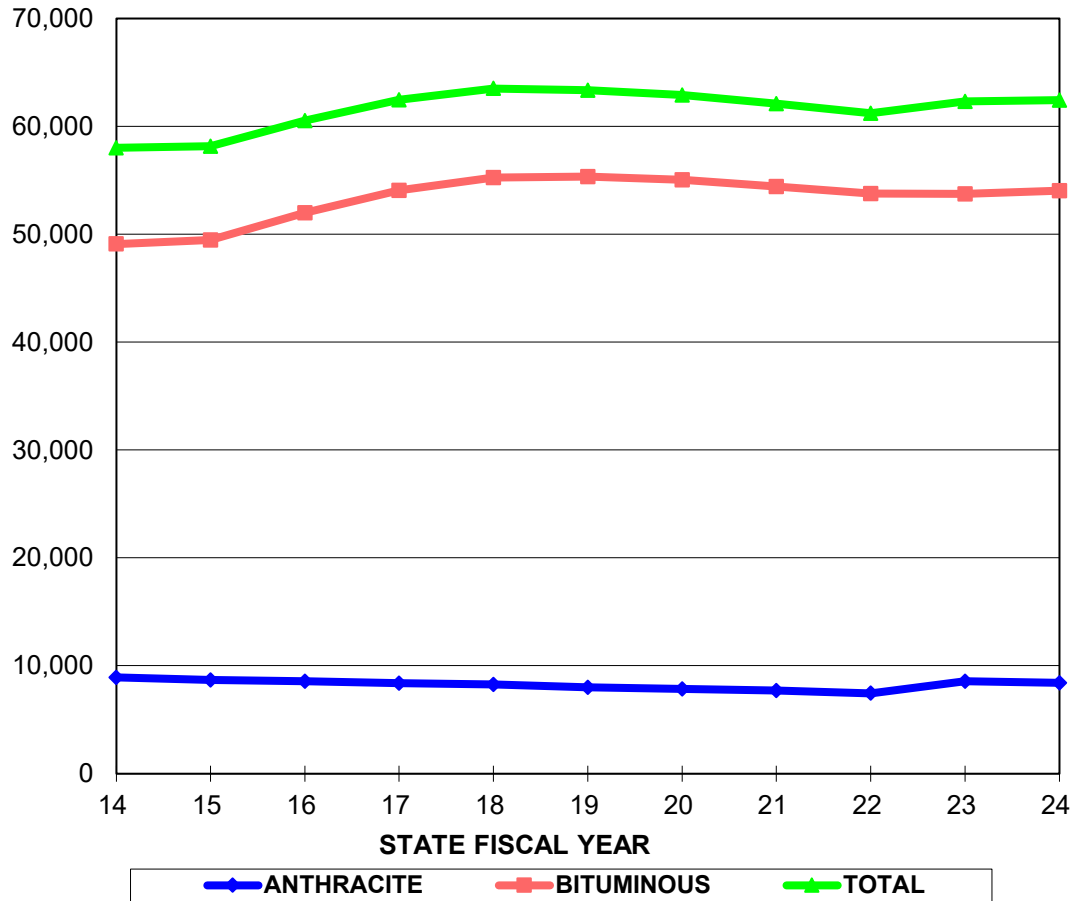

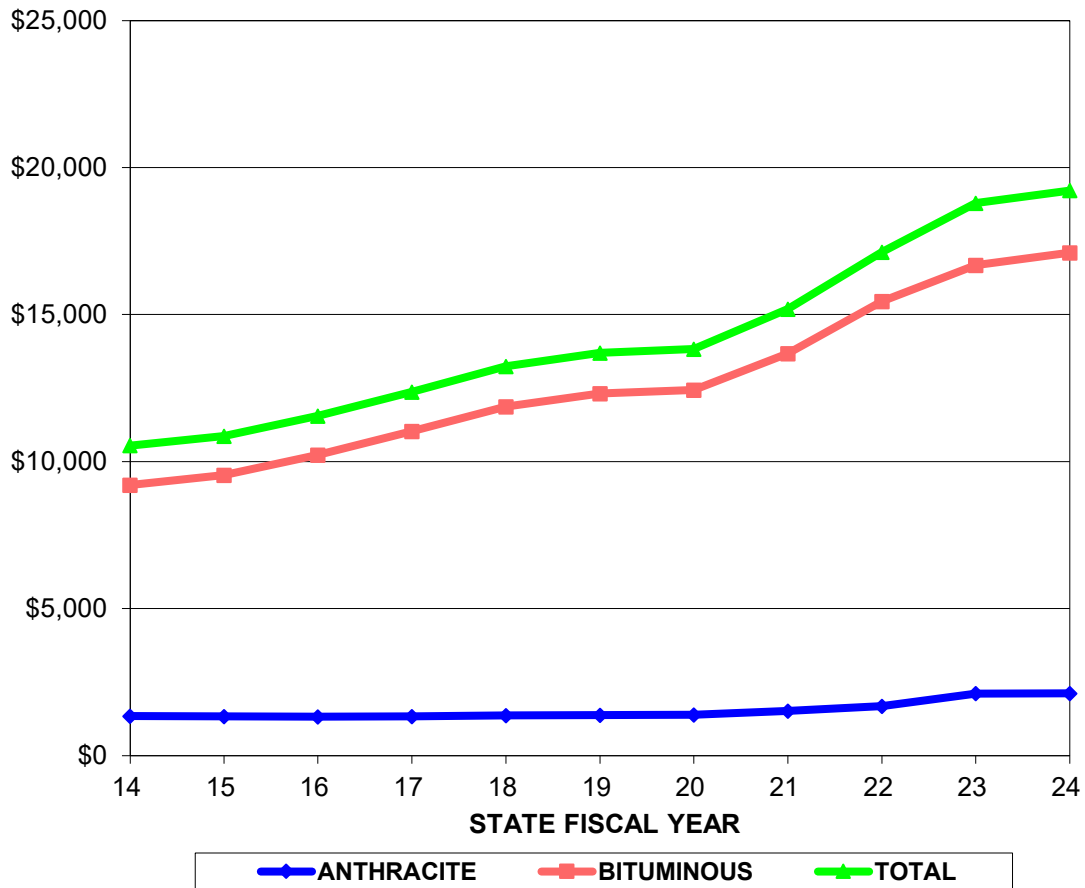
NUMBER OF INSURANCE POLICIES IN FORCE

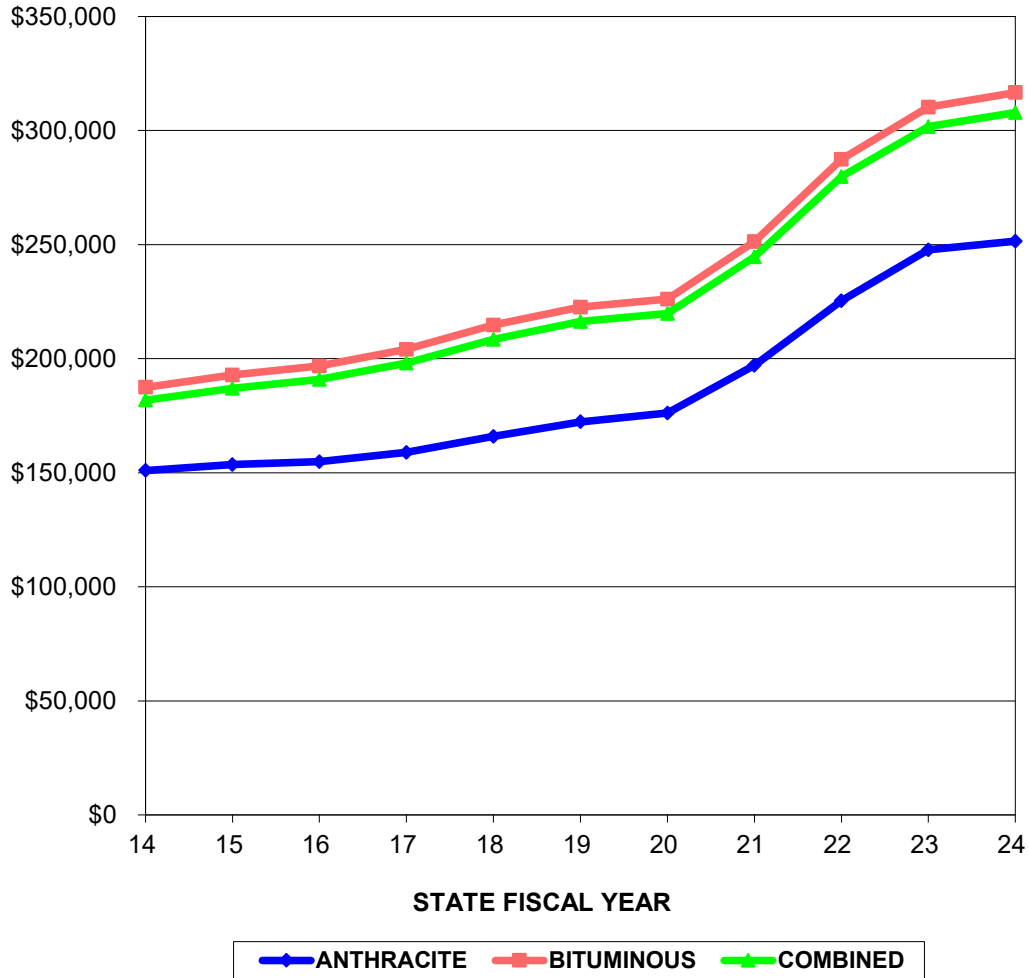
UNDERWRITTEN VALUE OF POLICIES IN FORCE (IN MILLIONS)

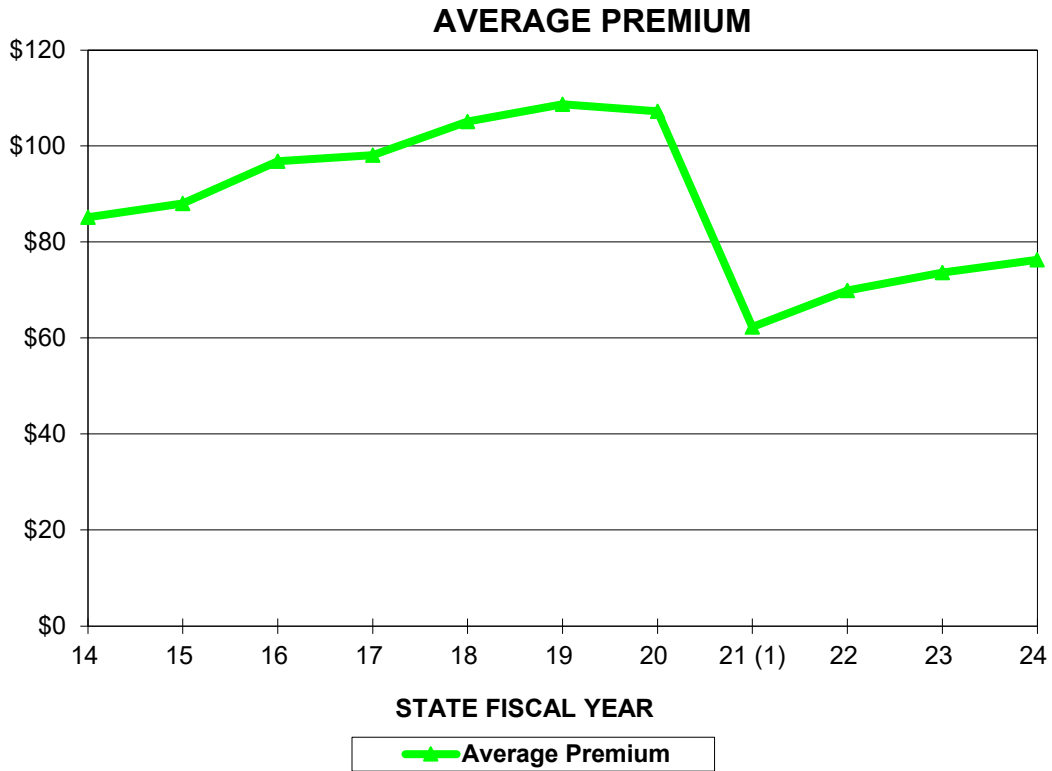

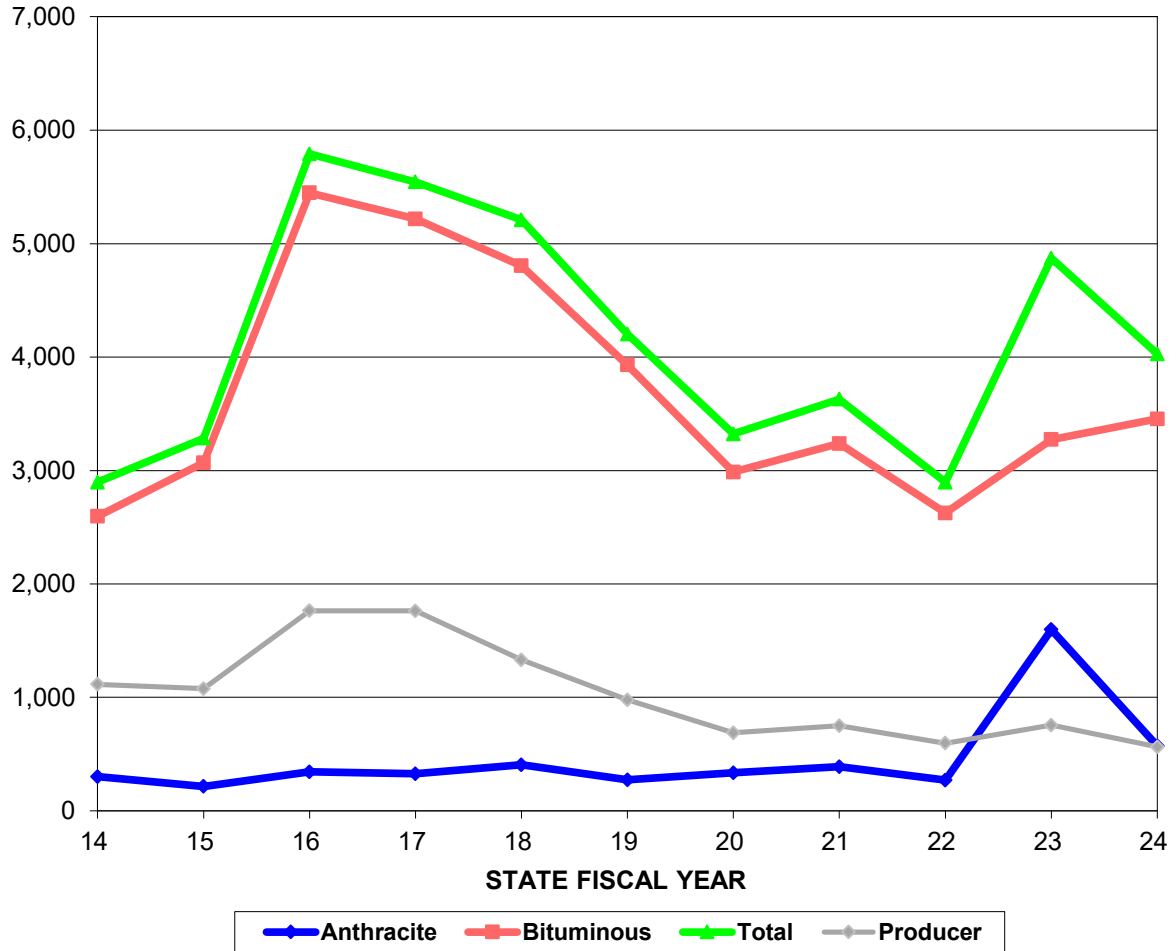

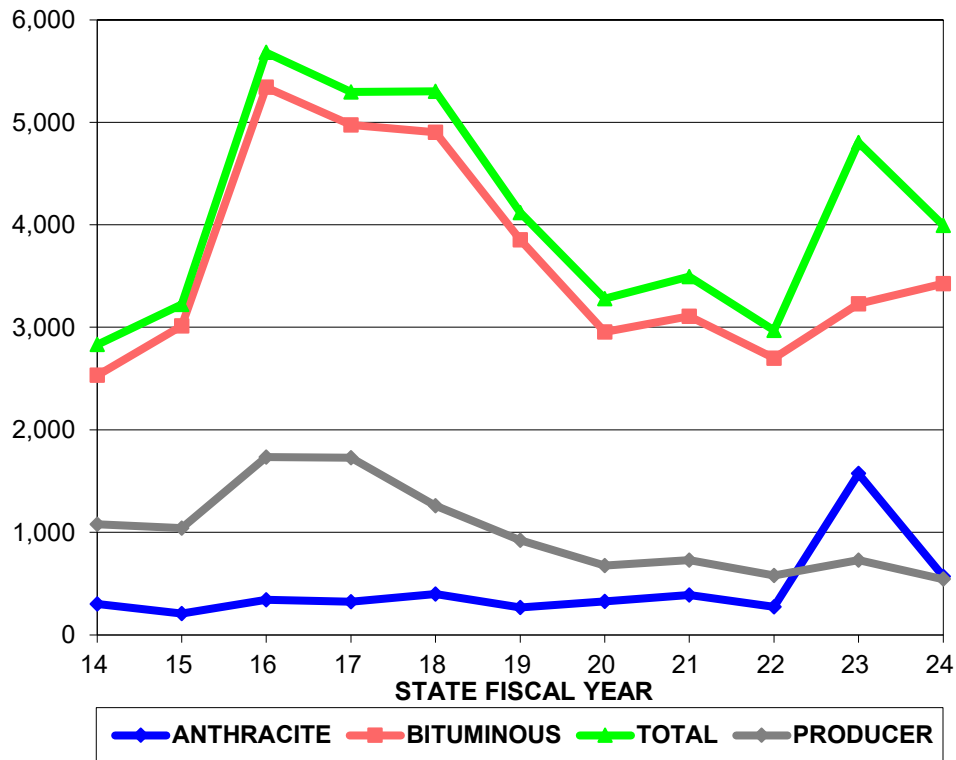
NUMBER OF APPLICATIONS FOR INSURANCE

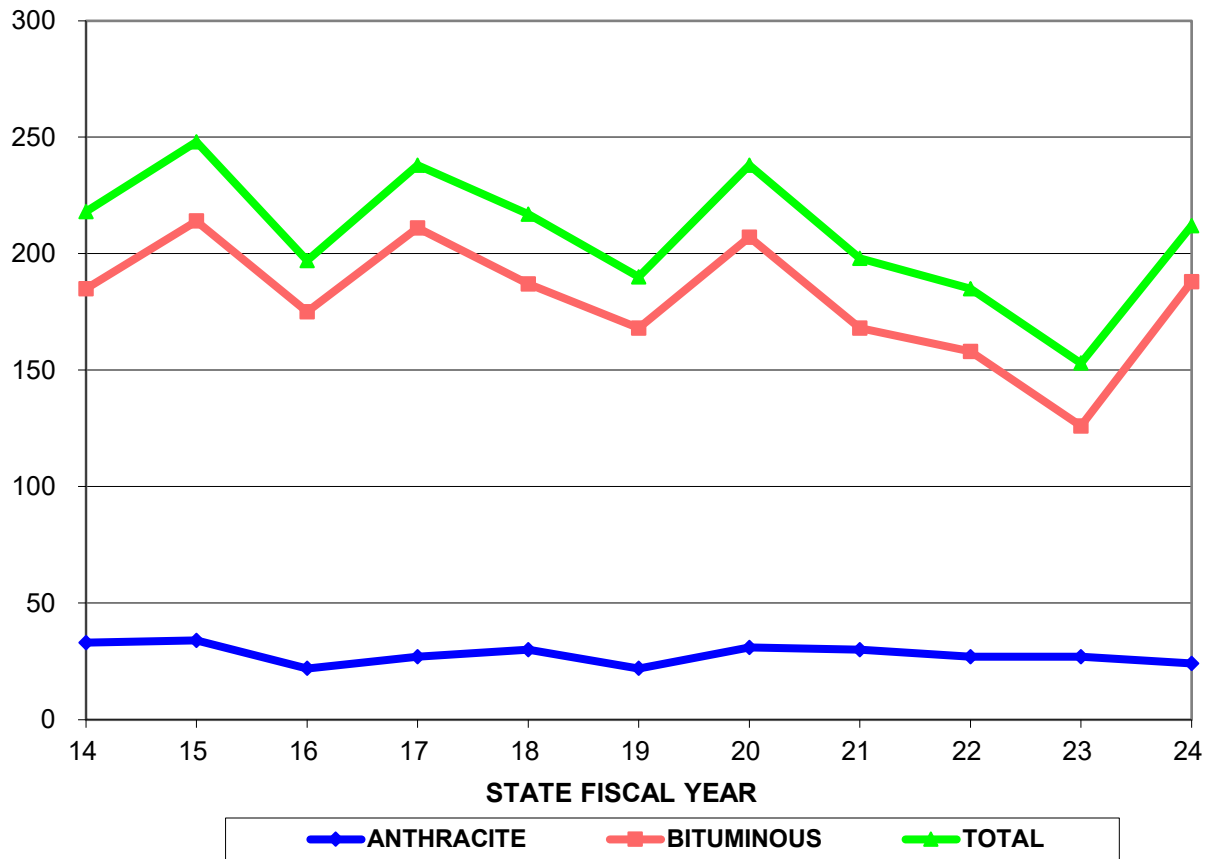

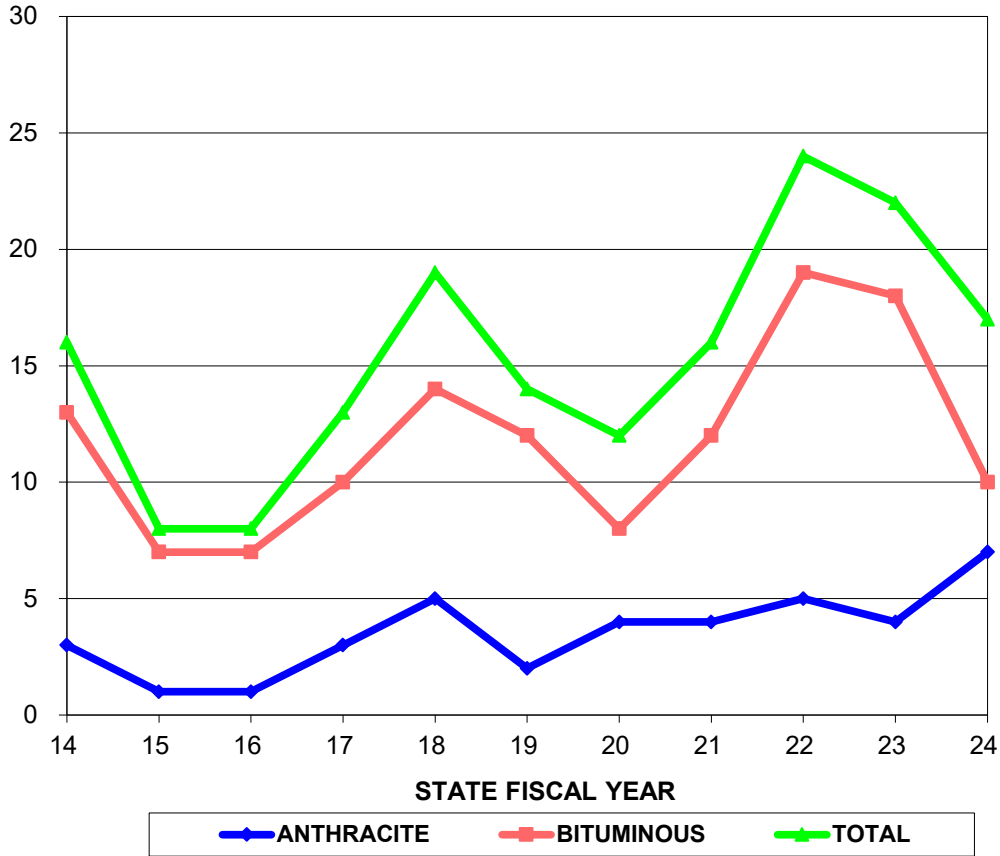

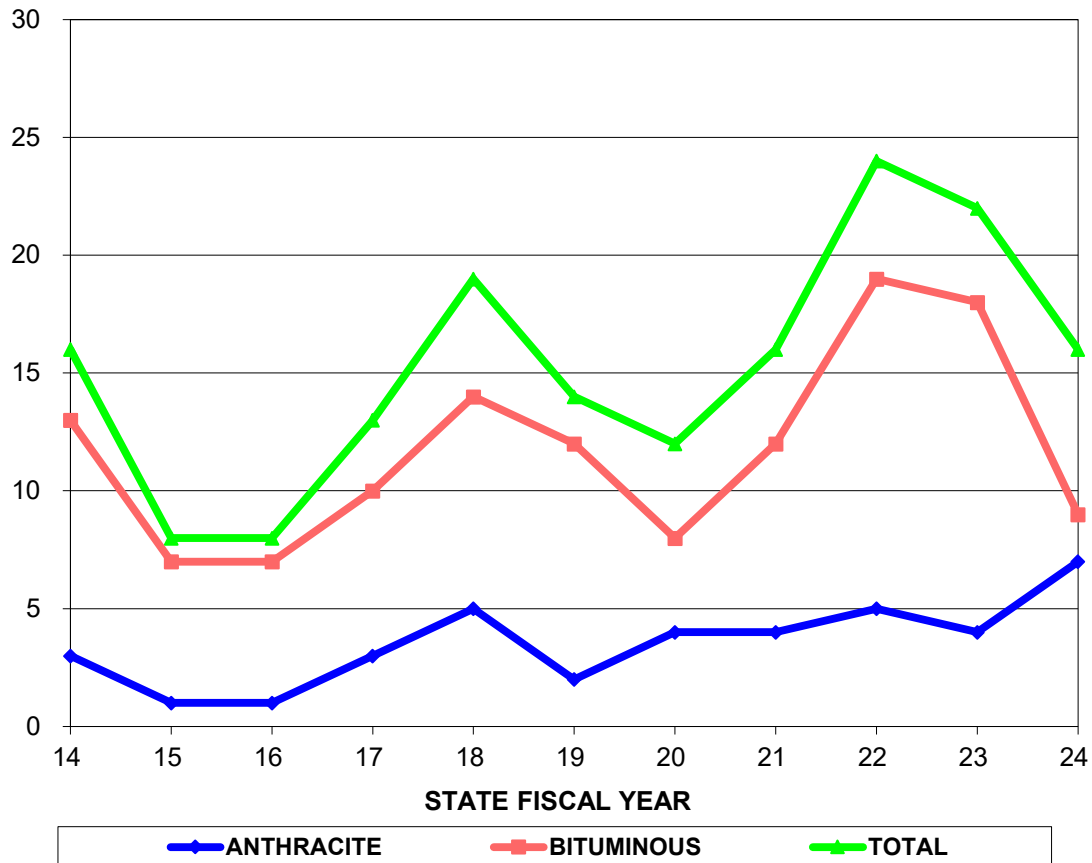

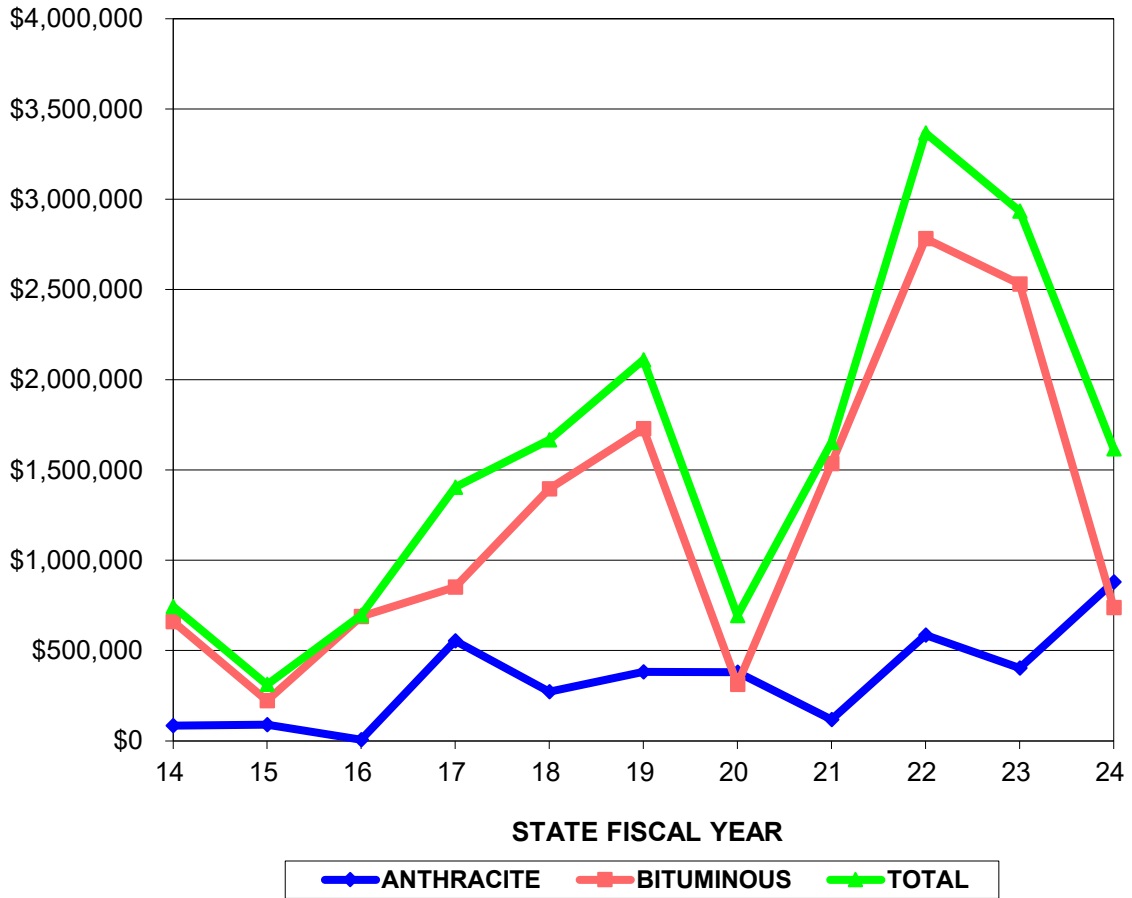

VALUE OF PAID CLAIMS

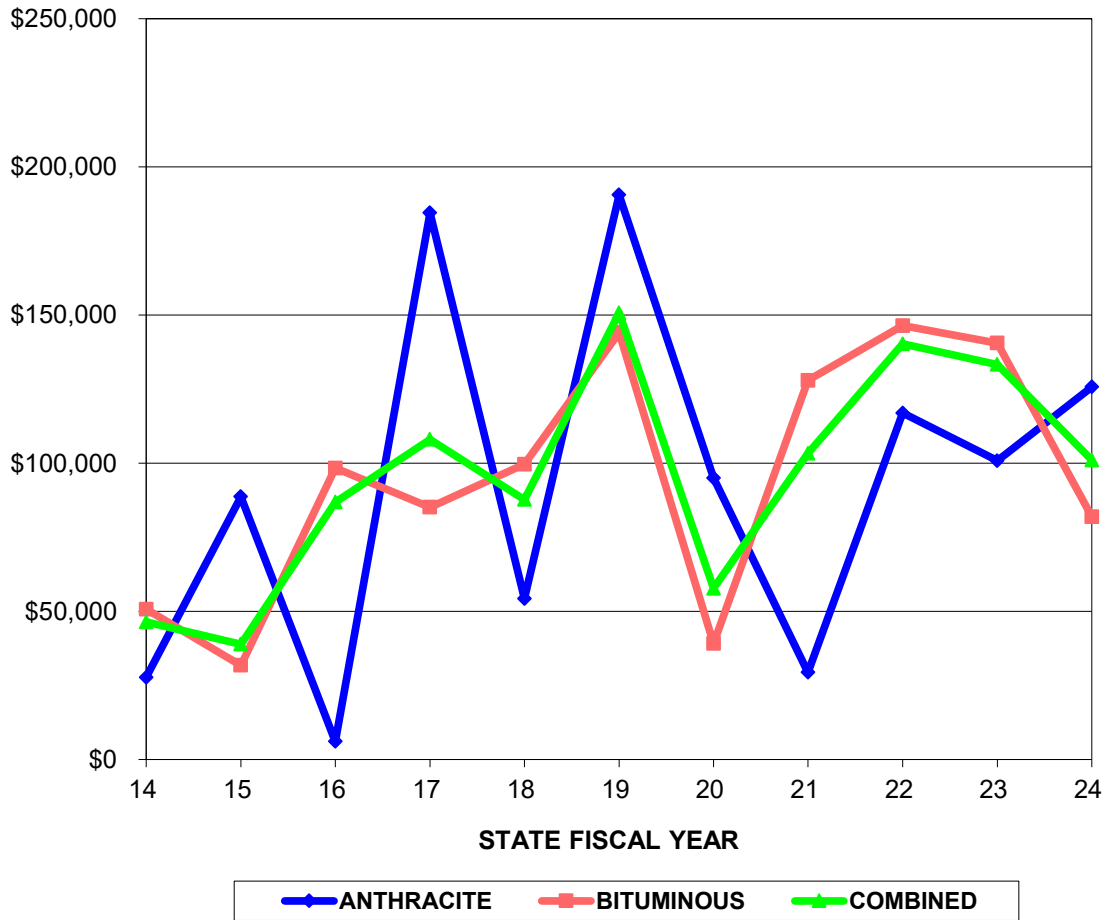

AVERAGE VALUE OF A PAID CLAIM

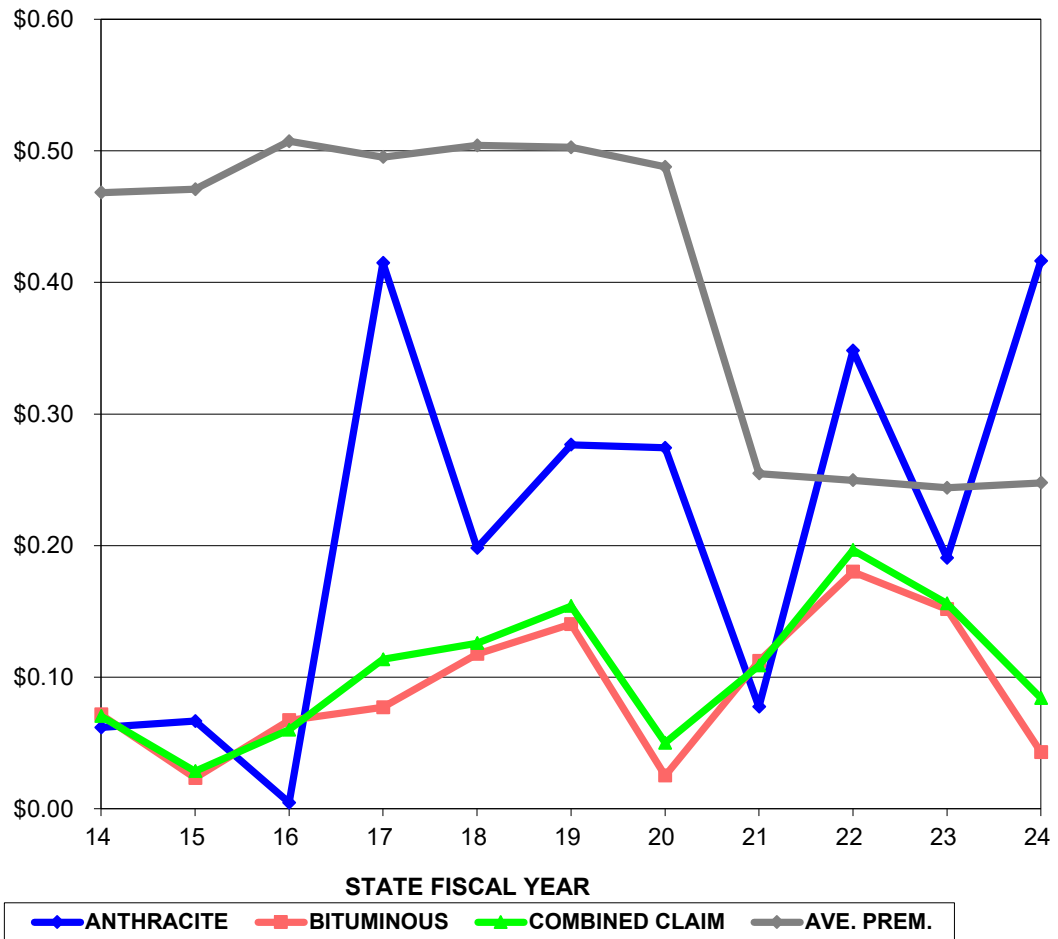

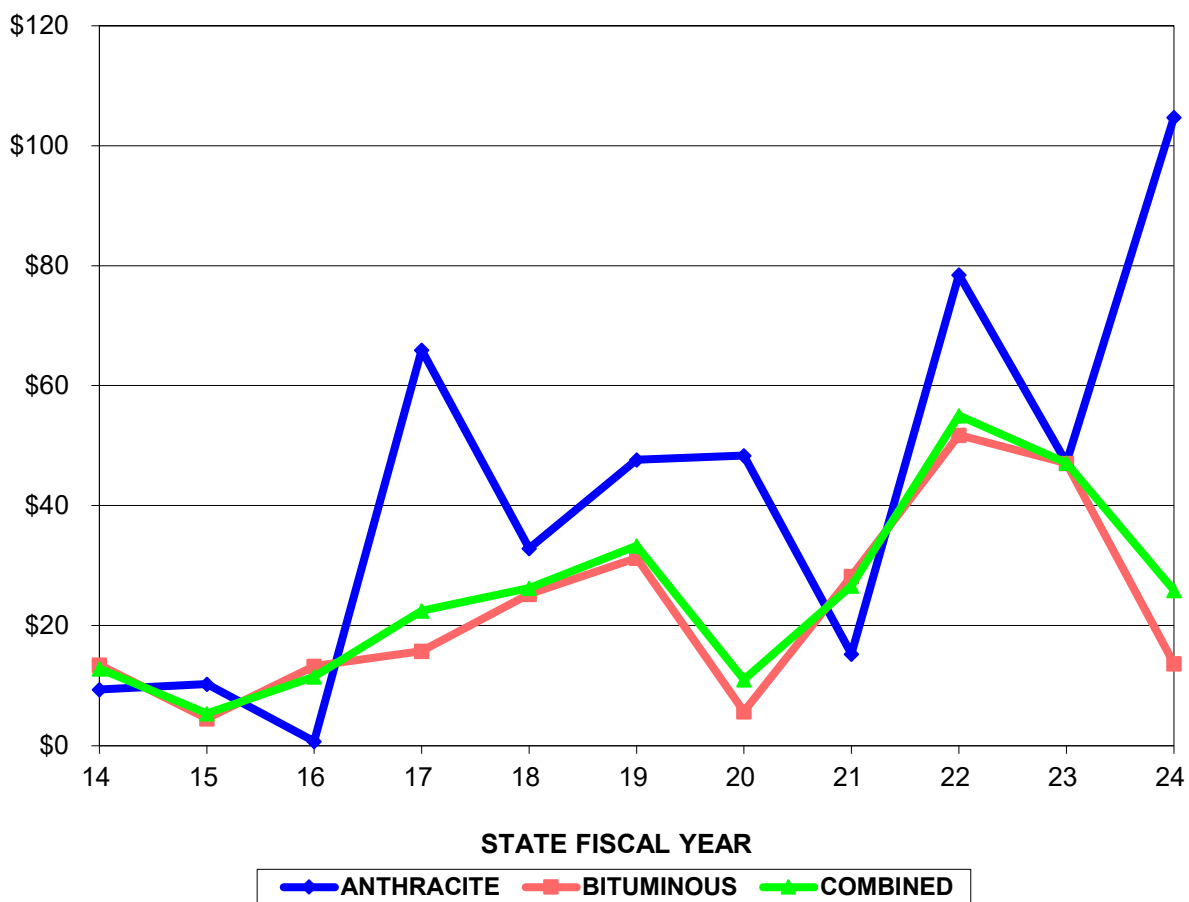
PREMIUM AND CLAIM AMOUNTS PER \$1000 OF COVERAGE
