**CALL TO ORDER AND APPROVAL OF MINUTES**

The meeting was called to order by Chair Adam Browning at 9:01 A.M. The meeting was conducted both in-person and on-line.

**PUBLIC COMMENT**

Scott Bieber – Sewage Enforcement Officer, Lehigh Valley Area

- Comment 1 – Regarding sewage flows for in-law suites. Noticed there is not an entry for proposed sewage flows for in-law suites in the sewage flow table. There should be an entry in the sewage flow table for in-law suites that should apply to either a detached or attached in law-suite. Proposed sewage flow should be 100 gallons per day per bedroom. Currently,

if this is an attached in-law suite to an existing dwelling the flows are 100 gpd per bedroom and if it is detached it is considered a separate 3-bedroom dwelling and would be 400 gpd. This does not make sense.

- Comment 2 – Regarding the definition of redoximorphic features, manganese is now listed as a redoximorphic feature, Scott believes this should not be the case. Scott does not believe this is an indicator of a shallow water table or an impermeable zone. Manganese should not be considered a redox feature for constituting a limiting zone. This should be removed from the regulations. If this remains as a redoximorphic feature, this will make it very difficult to get any in-ground systems as manganese is common.

Discussed proposed Chapter 73.44, Pressurized distribution design, 73.45, Dosing and effluent lift tanks, 73.46, Dosing Pumps, siphons, and lift pumps, 73.51, Subchapter F General, 73.52, Standard trenches, 73.53, Seepage beds, 73.54, Open-bottom subsurface sand filter seepage beds and trenches, and 73.55, Elevated sand mounds.
