#### Welcome

James Horton, DEP, welcomed everyone to the meeting, explained the meeting was being recorded, and provided helpful hints on the use of technology.

# **DEP Update**

James Horton presented an update of DEP activities to support the current State Water Plan and reviewed status of Committees' membership. For the next update of the State Water Plan, DEP plans to develop draft content for the plan during 2025, hold public hearings and meetings in the first quarter of 2026, and have a draft updated plan for the Statewide Committee to approve in the third quarter of 2026. DEP hopes to have the finalized plan completed by the end of 2027.

#### The timeline objectives include:

- 2025 Draft content for the updated plan.
- 2026, Quarter 1 Conduct a combined public hearing and public meeting
- 2026, Quarter 3 Send the draft plan to the Statewide Committee for approval

# Five Year Plan for Developing the Next State Water Plan

James outlined his five-year plan for updating the next State Water Plan. Activities to update the State Water Plan will include:

- 2023 Provide outreach activities throughout the state, recruit new members to fill all
  positions on the Regional Committees, and review the current plan and activities to
  move the plan forward.
- 2024 Implementation of recommendations and activities identified in the State Water Plan and provide an analysis of current activities.
- 2025 Reengage the work groups to draft updates to the State Water Plan.
- 2026 Complete editing, compile input and recommendations from Regional Committees and Statewide Committee and public review of the plan
- 2027 Respond to feedback from the public review, complete edits to the plan, and deliver the updated state water plan to the public.

### **Outreach Plans**

- James delivered a presentation to Pennsylvania Environmental Council in October 2023.
- DEP staff are developing tools to support outreach and tools in process of development includes:
  - Developing one-page posters (handouts) tailored to specific stakeholder groups.
  - Developing modular presentations on specific aspects of the state water plan that can also be tailored for specific audiences.

# **Analysis of Specific Topics- IWRM Workgroup**

DEP Staff are forming a IWRM Workgroup within the Statewide Committee to begin work on defining the problem and identifying solutions. Representation from each Regional Committee and the Statewide Committee is sought for the IWRM Workgroup.


# **CARPs in Progress**
