# Finalize December Meeting Summary

# Statewide Committee Update

William Morris stated the statewide committee and it's sub-committees are continuing to discuss items such as developing criteria for critical water planning areas, developing a framework for the regional components of the plan and identifying potential sources of funding for water planning.

## DEP Summary of Activities

Committee members were provided with a copy of the 2004 Review and goals for 2005. Stu Gansell reviewed this report and provided an overview of major activities to be accomplished in 2005. These activities include: improving registration responses from public water suppliers, pilot projects from the USGS screening tool, holding public hearings and begin to develop regional components of the State Water Plan.
