

Minutes of the July 23, 2020 Meeting
Small Water Systems Technical Assistance Center (TAC)

General Advisory Board business:

Three items of general business were discussed:

- The draft minutes from the February 26, 2020 TAC Board meeting were presented for discussion. No edits were requested. Jim Steele (PBA) made a motion to approve the Feb 26, 2020 minutes; Mary Roland (SBCSTPWWO) seconded the motion. The motion passed by a unanimous vote.
- Elections for Chairperson & Vice-Chairperson:
 - The nomination committee put forward Serena DiMugno as the nominee for Chairperson and Mary Roland as the nominee for Vice-Chairperson; there were no other nominees and there was no additional discussion.
 - Both Serena and Mary accepted the nomination and the nominees for Chairperson and Vice-Chairperson were each approved by a unanimous vote (Serena and Mary each abstained from the vote).
- Review of TAC Board Bylaws
 - Serena DiMugno (WWOAP) made a motion that was seconded by Mary Roland (SBCSTPWWO)
 - "A special committee should be formed to review the structure of the TAC Board and propose changes to the membership and Bylaws."
 - The discussion focused on the DRAFT edits for discussion proposed by DEP (as requested by the members at the November 2019 meeting) and that some members were not aware of the purpose and intent of the proposed revisions.
 - ✓ Several of the objectives of the TAC Board identified in the statute are no longer relevant.
 - ✓ Options discussed to make the Board relevant and inclusive of all types of public water systems: changing the name, adding a few additional member organizations (such as: PA Dept of Health, Water Quality Association, organizations that represent noncommunity water systems, a large public water system or technical expertise organizations). These options would require changes to the Bylaws or amending the statute.

- The motion passed by a unanimous vote.
- The subcommittee volunteers are: Chip Bilger (WWOAP), Serena DiMagno (WWOAP), Sharon Fillmann (AWWA), Mary Gaiski (PMHA), Christine Hoover (OCA), Joel Jordan (PRWA), and DEP (either Lisa Daniels or Brian Chalfant).

Discussion - TGD 1, *One Hour Reporting Guidance*

- TAC requested clarification on:
 - The Filter Backwash Recycling Rule (FBRR).
 - The differences between notification requirements for an accredited laboratory vs. a PWS.
 - Whether exceeding the MRDL level of 4.0 for chlorine at the EP requires notification because many larger PWSs maintain a residual close to 4.0 at their EP.
- TAC also requested additional examples be added.

Discussion - TGD 2, *PA's Capability Enhancement Strategy*

TAC requested that DEP:

- Add information about the USDA tool (include it as a new bullet item)
- Include other resources (add a table in the document and/or update the DEP webpage)
- Include references to other organizations

Discussion - *DWELR Revisions*

DEP will be revising the Drinking Water Electronic Reporting System to remain consistent with upgrades being made to the Green Port platform. The SDW data management staff are requesting that users of DWELR submit comments for what is and/or is not working well with the current system (what should be dropped, what should be changed and what should be added). Comments should be submitted to EP, PADWIS (ra-padwis@pa.gov).
