General Advisory Board business

The draft meeting minutes from October 27, 2022 TAC Board meeting were presented for discussion. There was a correction on Page 3 under lead service Line Inventories, 3rd bullet point to remove the double negative. No other edits to the minutes were noted. James Steele (PBA) made a motion to approve the October 27, 2022 minutes as corrected and amended. Tesra Schlupp (PIIA) seconded the motion. The motion passed by a unanimous vote.

Q&A for LCRR Service Line Inventory Requirements

DEP staff from the Bureau of Safe Drinking Water were available to answer questions. The TAC Board requested clarification on the following items.

- The number of excavations needed to determine the service line is not lead. DEP outlined possible service line determination methods.
- Updates or additional guidance for water systems that attended the early training sessions. DEP's LCRR website has updates, the training guide and job aids. An alternative form to DEP's template is available by request.
- Whether a customer's distribution system service lines are to be included in the inventory if the water system sells to a customer that has its own distribution lines (such as a manufactured home community). EPA's guidance states that the water system does need to include the customer's service lines. DEP is requesting clarification and legal authority information from EPA.
- Request for clarification on the Lead Service Line (LSL) Accelerator project. Pennsylvania is one of 4 states that EPA has selected to provide technical assistance specific to service line inventories and lead service line replacements to small water systems. DEP has identified approximately 10 systems for this assistance with the expectation that lessons learned case studies will be created to assist all water systems.

PFAS Sampling Fact Sheet

DEP provided an update on the draft PFAS Sample Collection Fact Sheet. The TAC Board had the following comments.

- DEP should clarify how water systems should address potential cross-contamination from the water pipe supplying the sampling tap.
DEP noted that the field blank should detect this type of cross-contamination and that the water system could also collect a source water sample. If the water system chooses to not have the source water result reported to DEP, the sample should be noted as non-reportable, and the water system assumes responsibility for notifying DEP if any results that exceed an MCL value.
- DEP should clarify whether field blank detections or QA/QC issues invalidate a result thereby requiring a replacement sample. DEP noted that there is a process for labs to request to report results with data qualifiers caused by QA/QC failures unless the failure is such that the lab determines the result is invalid.

DEP recommended that water systems review and comment on the proposed EPA PFAS Rule during the public comment period. The deadline to submit comments is May 30, 2023.

Bipartisan Infrastructure Law

Jay Patel, Bureau of Clean Water presented an overview and outline of the federal funding. The TAC Board requested clarification related to funding for on-lot septic systems. TAC members were advised to contact PENNVEST for assistance on projects.
