**General Advisory Board business**

The draft meeting minutes from February 14, 2024 TAC Board meeting were presented for discussion. James Steele (PBA) made a motion to approve the February 14, 2024 minutes as presented. Mary Gaiski (PMHA) seconded the motion. The motion passed by a unanimous vote.

**Elections for Chairperson and Vice-Chairpersons**

- Nomination for Chairperson: Serena DiMagno; Nomination for Vice Chairperson: Sharron Fillmann  
Motion was made by James Wheeler and 2<sup>nd</sup> by James Steele to close nominations and approve nominations. Motion passed by a unanimous vote.
- Discussion on the purpose of, and need for, sub- committees and additional Vice Chairs.
  - Motion was made to table the discussion until the next meeting August 14<sup>th</sup>, 2024 by JT Hand and 2<sup>nd</sup> by Matthew Lamb. Motion passed by a unanimous vote.
  - DEP is tasked with looking up the historical information on sub committees from early TAC formation.

**Presentation – Drinking Water Accredited Laboratories**

- DEP provided an overview of the Drinking Water Accredited Laboratories
  - There are ~ 7,900 public water systems with 9,200 entry points.
  - There are about ½ the number of labs accredited by PA in 2024 than there were 20 years ago.
- DEP also provided an overview of the process for inspections at drinking water accredited labs by Bureau of Safe Drinking Water (BSDW) staff.
  - Starting with commercial labs, BSDW staff will be conducting inspections at laboratories accredited for drinking water testing to educate and evaluate compliance with the provisions of Chapter 109 SDW regulations that apply to laboratories but are not evaluated by DEP's Lab Accreditation Program (e.g. sample collection and data reporting).

- The inspections are to ensure that samples are being collected in accordance with the appropriate sample siting plans regardless of whether a contract lab or water system personnel are collecting the samples.

### **SDW Informational Session**

LCRR: Remember that the SLI must be completed and submitted to DEP by October 16, 2024.

PFAS:

- The Q1 2024 PFOA/PFOS monitoring results were posted to the PFAS MCL Rule webpage. Monitoring was completed as required by 90% of the PWSs required to sample in 2024.
- EPA published the final PFAS Rule on April 26, 2024. The implementation dates are different for monitoring and MCL compliance. PA DEP will have to revise chapter 109 (through a formal rulemaking) to incorporate the federal provisions that are more stringent than the current PFAS MCL Rule.
- Most labs accredited by PA are able to meet the analytical requirements specified in the federal rule. The methods approved by both PA and EPA include all 6 PFAS regulated in the federal rule. Each PWS will have to specifically request that their sample(s) be tested for these 6 PFAS.
- Approximately 14% of the systems that submitted results to date have levels for PFOA, PFOS (or both) that are below the PA MCLs but exceed the EPA MCLs

CCR3: The revised CCR Rule (CCR3) was announced as final on May 15, 2024. *UPDATE: The final rule was published in the Federal Register on May 24, 2024.*

Cybersecurity: One of the most basic protective measures PWS staff can & should take to prevent a cyber intrusion is to change the default password on equipment. Each PWS should also have separate firewalls/networks and check outward facing SCADA alarms.
