Triennial Review 2008 Final Rulemaking

Tom Barron, BWSFR, <u>tbarron@state.pa.us</u>, presented and discussed revisions to **Chapters 93** and **16** in the final rulemaking package in preparation for an upcoming Environmental Quality Board (EQB) meeting.

Donald Bluedorn moved to endorse the proposed Triennial Review 2008 Final Rulemaking update subject to the caveat that the department recalculate the molybdenum standards, or that the point where the criterion applies be moved to the point of water supply withdrawal. The motion was lost after debate.

Edith Stevens moved to endorse the proposed Triennial Review 2008 Final Rulemaking update as presented. The motion was lost.

Howard Neukrug moved to provide WRAC's support of the Triennial Review 2008 Final Rulemaking update along with notice to the Commonwealth and the EQB that some members of the WRAC have significant concerns with the molybdenum criterion and the health data used to create that particular criterion. The motion was adopted unanimously.

Buffers 100 Initiative
