EPA's Environmental Justice: A New Model for Planning in Underserved Communities Call-On Wed., Nov. 12 OEA Director Kim Morewood joined the Planning and the Black Community Division of the American Planning Association; the Planning Webcast Series Consortium; and the U.S. Environmental Protection Agency's Office of Environmental Justice for a conversation on environmental justice. Expert speakers discussed how environmental justice is a forward-thinking, sustainable approach. Participants learned how citizens and professionals are making a visible difference in communities across the country through environmental justice. Presenters demonstrated why a discussion about environmental justice is important given the renewed focus on social equity and planning among professionals. Items addressed included: Tools, practices, and funding programs that will improve the proficiency of planners when working with underserved communities; Techniques for encouraging environmental justice that can be integrated into place-based efforts; Key strategies and best practices for addressing issues which target the social pillar of sustainability. Speakers included Charles Lee; Marva King, PhD; and Carlton Eley of the U.S. Environmental Protection Agency as well as Mildred McClain, Ed.D. of The Harambee House, Inc./Citizens for Environmental Justice. Shell Proposed Petrochemical Facility Community Meeting, Midland, Beaver County: - On Thurs., Nov. 13, OEA Director Kim Morewood attended a community meeting for Royal Dutch Shell's proposed petrochemical plant in Beaver County. Keystone Landfill, Dunmore Borough, Lackawanna County EA Alice Wright received over 50 community responses from residents of Dunmore indicating that they are opposed to any expansion of the landfill located in Dunmore Borough. Wright forwarded the responses to CRS and LGL in Northeast Region and OEA Director. The Northeast Region is gathering community comments to one location. OEA Dir. Morewood met with NERO Regional Director Mike Bedrin, CRC Colleen Connolly and Waste Program Staff on Tues., Nov. 18 to discuss an outreach plan. approval for the modification of the existing permit to increase the volume of sludge accepted at the facility from 120,000 gallons per day to 200,000. The permitted operation and waste types will not change. Hindt held a question and answer period on questions posed by CEP members. CEP members who attended the conference gave an update and discussed outcomes and accomplishments of the CEP Environmental Health and Environmental Justice in PA conference and recommendations for moving forward with the final report. Councilwoman West discussed City governmental activities in connection to recycling, education and training in the school system, all city municipal buildings are recycling and the partnerships with the County, Widener University and Chester school district. West introduced the City's candidates that will be attending the Host Municipality Inspector training in Harrisburg in December. Dr. Strand and John Waffenschmidt gave an update on the Save Your Soles Campaign and announced the (6) names of the (6) scholarships that were awarded to Chester students. The presentation focused on how Covanta does Risk Assessments both from health and economic perspective and how Covanta deal with issues like communities with respect to risk perception, risk communication and regulations. Waffenschmidt covered Health Risk Assessment in the Energy-from-Waste Industry, operating and communicating in an EJ community, and sustainable considerations and sustainable building and public infrastructure in urban/suburban/rural communities. Keep PA Beautiful (KPB), Chester, Delaware County- EA Alice Wright attended a Chester City Council meeting for a KPB presentation by Heidi Pedicone, Director of Programs, KPB to Chester Councilmembers Portia West, Al Jacobs and Elizabeth Williams, Mayor John Linder and Chief of Staff Ron Starr, Widener Dr. Kathy Hornberger, and PRC Mario L. Cimino. Pedicone gave an overview of KPB and confirmed Chester City is a candidate for KPB program. Pedicone pointed out the benefits for Chester becoming an Affiliate: awards recognition and grants, resources, tools and training materials, a Board, professional training, surveillance cameras, etc. At the Environmental Justice Advisory Board Meeting held at Chester City Hall during the early part of 2014, Councilwoman West asked the DEP RDO, Cosmo Servidio, for assistance with illegal dumping in Chester. After researching the Delaware County's Illegal Dumping Survey report, we found Chester City had 14 out of the 24 dump sites in the entire county. Councilwoman Portia West initiated a Keep Chester Beautiful campaign to reduce illegal dumping sites in Chester. Pedicone explained the process for Chester City to become an Affiliate starting with forming a Team, obtaining a letter of support from the highest elected official for the jurisdiction interested in affiliation (Mayor Linder), securing the initial Affiliate fee and submitting the application to KAB. The Affiliate Application fee for Chester City is based on population of 35,000+ at a one-time certification fee of \$3,000. Dr. Strand sent a letter to Covanta requesting on behalf of the City of Chester and Councilwoman Portia West, that Covanta be the Donor for the one-time Affiliate Application fee of \$3,000, payable to Keep America Beautiful. Delaware Conservation District, Delaware County Recycling Coordinator, PA DEP RDO, WM, Darby Creek Valley Association, and Chester Ridley/Crum Watershed, PRC and the CEP are all supporters. The City has begun forming a committee for planning the Team that to date, includes Chester City Council and the Mayor, CEDA, PRC, CEP and Widener. Pedicone said as an Affiliate they can expect to have commitments and partnerships from companies and agencies like: DELCORA, PennDOT, Covanta, Delaware County, the business community and local Watersheds. University of Pittsburgh's Center on Race and Social Problems: Pittsburgh's Racial Demographics 2015: Differences and Disparities Demographic Report: Office of Environmental Advocate Director Kim Morewood and EA Lisa Kasianowitz attended a news conference at the University of Pittsburgh on Tuesday, Jan. 13, announcing the completion of a new report on Pittsburgh's racial demographics produced by the university's School of Social Work. The dean of the school, Larry Davis, discussed that the report provides indicators of quality of life by race and ethnicity based on diversity, families, education, economics, interracial group relations, health and criminal justice. The purpose of the report is to educate and inform people of the disparities that exist, and are growing, in the Pittsburgh area and prompt discussion and social change. Keystone Sanitary Landfill, Dunmore Borough, Lackawanna County- EA Alice Wright continued forwarding bulk comment letters opposing the Keystone Landfill expansion permit in Dunmore Borough to NERO CRC and Central Office OEA. Chester Environmental Partnership (CEP), Chester, Delaware County- EA Alice Wright attended the CEP meeting that was hosted by Chester City Councilwoman Portia West and held at Chester City Hall in the Community Room. The discussions included a presentation by Alexander Mandell, Community Involvement Coordinate (CIC), EPA Region 3. Mandell provided a brief history on the Metro Container Superfund site in Trainer and on EPA superfund program. West introduced and announced that two City employees attended the HMI training in Harrisburg and are now certified to be the City Host Municipality Inspectors. West provided the CEP with numerous City Hall activities and updates on Keep PA Beautiful project and collaborations, bridge improvement projects and that PennDOT is the lead and oversees the improvements, a plan to add additional trucks for snow removal, cost benefit and partnerships.
