## Gov. Wolf Appoints Patrick McDonnell Acting Secretary of DEP

HARRISBURG -- Governor Tom Wolf on May 20 appointed Patrick McDonnell as the Acting Secretary of the Department of Environmental Protection (DEP) following the resignation of John Quigley.

McDonnell most recently served as DEP's director of policy where he oversaw the agency's regulation and policy development processes. In addition, McDonnell ran the State Energy Office and was charged with coordination of renewable energy and energy efficiency issues.

"My years here have taught me that DEP is one of the best teams to be a part of in the Commonwealth," McDonnell said in an email to staff. "Together I know we will continue to carry on some of the most vital work in state government."

### DEP Schedules June 20 Public Meeting and Hearing on Changes to Air Quality Plan Approval for Proposed Lackawanna County Power Plant

WILKES-BARRE -- DEP will host a public meeting and hearing on revisions to an air quality plan approval for Lackawanna Energy Center, LLC. The company is proposing to build and operate a 1500-mega-watt natural gas-fired power plant in Jessup, Lackawanna County. The meeting and hearing will take place from 6 to 9:30 P.M. on Monday, June 20, at Valley View High School, in Archbald.

Lackawanna Energy Center submitted a plan approval application on February 24, 2016, to revise the layout of the plant to include three smaller steam turbines and three smaller air-cooled condensers in place of the originally planned single steam generator and single air-cooled condenser. The steam turbines and air-cooled condensers are not air emission sources, therefore, this plan approval application does not change any emission limits imposed under the previously issued plan approval in December 2015.

WILLIAMSPORT -- Sixteen individuals from various county, state and federal agencies recently completed a 40-hour Hazardous Waste Operations and Emergency Response (HAZWOPER) course at DEP's North-central Regional Office in Williamsport.

This five-day course is designed for personnel involved with the investigation and remediation of uncontrolled hazardous waste sites and response to accidents and/or releases involving hazardous materials. The course provides fundamental information required to meet the 40-hour training requirements of OSHA's Title 29 regulations.

Course work included instruction and discussion of personal protective equipment (PPE), analytical instrumentation and field detection methods, decontamination of personnel and equipment, hazard recognition and containment/remediation, as well as practical application exercises involving Level B PPE.

Training was provided by HazTrain of Waldorf, MD in conjunction with the federal Environmental Protection Agency. There was no cost to the Commonwealth for this course.

## Faculty Learn to Teach About Energy Efficiency at DEP-Funded Course

PHILADELPHIA -- Nine university faculty attended a free three-day workshop this week at The Navy Yard in Philadelphia to learn how to instruct a course titled "Leadership in Building Energy Efficiency."

The workshop is for participants to return to their respective higher education institutions and teach modules from the class or the whole course, which focuses on the identification of low and no-cost energy saving opportunities in commercial buildings via a process called "re-tuning."

Re-tuning is a systematic process that identifies operational problems by leveraging data collected from a building walk-down and correcting those problems at no- or low-cost. The course introduces the topics of energy management through no-cost and low-cost operational measures in the following major focus areas: lighting, building envelope, hot water/steam systems, HVAC, compressed air, indoor environmental quality and plug loads.

Development of the course by Penn State's Architectural Engineering faculty was funded through DEP's U.S. Department of

Energy State Energy Program (SEP) funds. The workshop itself was also paid for via SEP funds.

## Buoy to Provide Water Quality Info about Presque Isle Bay

ERIE -- DEP recently installed a new water quality buoy in Presque Isle Bay in Erie. The buoy will provide information about the daily conditions of the bay and help staff in monitoring for harmful algal blooms.

The buoy records temperature, dissolved oxygen, pH, conductivity, turbidity, and total algae every 20 minutes. It was purchased with federal Great Lakes Restoration Initiative funds.

The buoy is one of several deployed in partnership with the Regional Science Consortium, Pennsylvania Sea Grant, Pa. Fish and Boat Commission and Erie County Health Department to provide information for boaters, anglers and swimmers about changes in environmental and weather conditions.

DEP staff regularly test the health of lakes throughout the commonwealth. Recently, Sherrill Leap, a water pollution biologist from DEP's Wilkes-Barre Office took a sample from Lilly Lake near Shickshinny in Luzerne County for chlorophyll A, a group of related green pigments found in bacteria that aids in the growth of algae and invasive plants in bodies of water.

## **Penncrest High School Wins 2016 Pa. Envirothon**

**MIFFLINBURG** -- The team from Penncrest High School in Delaware County is the winner of this year's Pennsylvania Envirothon. Penncrest scored 548.3 points out of a possible 600, earning top honors and the chance to represent Pennsylvania at the NCF-Envirothon North American competition July 24–29 at Trent University in Peterborough, Ontario Canada.

At the Envirothon, five-member teams participate in a series of field station tests that focus on five topic areas – soils and land use, aquatic ecology, forestry, wildlife, and environmental issues. The 2016 current environmental issue focused on Invasive Species. The teams also prepare and deliver oral presentations to panels of judges who evaluate each team on its problem-solving capabilities, oral presentation skills and recommendations to help solve the specific environmental challenge, which relates to the current environmental issue.

High school students from 65 Pennsylvania counties took part in this year's competition. Second place went to Lebanon County's Palmyra Area High School, third place was Carmichaels Area High School, Greene County, Neshaminy High School, Bucks County finished fourth and YHSA Homeschoolers, York County, finished in fifth place.

## **DEP Staff, Volunteers Help as Falcons Take Their First Flights**

**HARRISBURG** -- All three of the young peregrine falcons that hatched last month in a nest on the 15th floor of the Rachel Carson State Office Building in Harrisburg took their first flights this week.

DEP staff, summer interns and a group of dedicated volunteers watch out for the birds as they learn to fly. The birds sometimes land on rooftops and ledges of other nearby buildings and need to be rescued if they encounter trouble. When they're rescued, DEP staff do a quick check to look for any signs of injury or disease, then return them to the roof of the building where they resume flying.
