B. Why is the petitioner requesting this action from the Board? (Describe problems encountered under current regulations and the changes being recommended to address the problems. State factual and legal contentions and include supporting documentation that establishes a clear justification for the requested action.)

B. Bushkill Township is requesting the upgrade of Sobers Run (main stem, east and west branch) from High Quality (HQ) Stream to Exceptional Value (EV) through the category of 4.2 (c): Outstanding national, state, regional, or local resource water. The Township is requesting the upgrade to obtain higher level of protection to coincide with the land use regulations and land conservation efforts to protect the Sobers Run watershed. A level of threat exists due to the development pressure and loss of critical watershed and riparian habitat. Unless the lands that provide groundwater recharge or that surround water supplies are permanently protected, the natural resources and water quality will be degraded. The Township's request for EV upgrade satisfies the qualifers of both Coordinated water quality protective measures along a watershed corridor (local and regional) combined with Coordinated water quality measures with real estate interests. The Sobers Run watershed

includes area of statewide and local significance including PA Department of Conservation and Natural

Resources (DCNR) State Park- Jacobsburg Environmental Education Center (1100 acres of State Park land);

Areas unprotected that have statewide significance for protection of biological diversity include the Blue

Mountain, Rismiller Woods, Moorestown Wetland, and Knechts Pond, as identified in The Nature

Conservancy's A Natural Areas Inventory of Lehigh & Northampton Counties, Pennsylvania, 2002.

Over the past 5 years, six plans were completed which all support protecting Sobers Run including: Sobers Run Coldwater Conservation Plan (2005), Two Rivers Area Greenway Plan (2005), Nazareth Area...2030

Multimunicipal Comprehensive Plan (2006), Bushkill Township Open Space Plan (2007), Lehigh Valley Greenways Plan (2007), and PPL Corridor Landowner Outreach report (2008).

Plan Actions completed to date include:

- Official Map (Ordinance No.2005-01) adopted April, 2005; result of Sobers Run Coldwater Plan and Two Rivers Area Greenway Plan

- Act 167 Stormwater Management Ordinance (No.2007-02) adopted April 2007; result of Nazareth Area...2030 Multimunicipal Comprehensive Plan

- Lehigh Valley Planning Commission (LVPC) hired to establish coordinated regional zoning with the 8 municipalities in the Nazareth Council of Governments (COG), including Bushkill Township

- Conservation easements on 25.47 acres of woodlands and riparian areas via dedication of open space out of 81.74 total subdivision acres; result of the Official Map

Bushkill Township Open Space Referendum passed by voters November 2005; 0.25 percent tax increase in earned income tax for open space fund; \$450,000 annually acrual for purchase and/or easement of high value conservation areas in LVPC Natural Resources Plan, A Natural Areas Inventory (2002), and Bushkill Township Open Space Plan; additional funds leveraged via Northampton County Open Space Program and DCNR
PPL Corporation land donation of 15.9 acres along Sobers Run to Bushkill Township; additional conservation easement of 47.7 acres along PPL and Sobers Run Corridor; result of Bushkill Township Open Space Plan, Lehigh Valley Greenways Plan, and DCNR Lehigh Valley Greenways initiative

- Over 100 acres of land conservation outreach initiated by Heritage Conservancy

- 119 acres acquired on Blue Mountain (Kittatinny Ridge) - headwaters to Sobers Run and Bushkill Creek
