Hi Matt,

Per our discussions, after the revision made to the Approval of CO No.4, there was still a discrepancy in the correct distribution of funding for Task 1000 and Task 1010. Upon looking into this further, HDR and the Department identified that the discrepancy was the result of the Department and HDR simultaneously attempting to correct an error previously identified with CO No.3 which resulted in compounding the budget discrepancy. Below is a corrected Estimated Cost Summary Table representing the correct budget approvals for CO No.4. No new Project Management time was added to CO No.4. All Project Management Time was agreed to in the approval of CO No.3. The budget correction in Both Task 1000 and 1010 is a reallocation of funds to cover the time approved as part of CO No.4. The approved authorized budget for CO No. 4 remains the same as does the overall Requisition Budget.
