This municipal notice, under the requirements of Act 14, 97 P.S. § 510-5, is to inform you that we are applying for coverage under the Erosion and Sediment Control General Permit (ESCGP-3) for Earth Disturbance Associated with Oil & Gas Exploration, Production, Processing or Treatment Operations or Transmission Facilities from the Pennsylvania Department of Environmental Protection (DEP):

Project Location: Tilghman Lateral starts Southwest of the intersection of Ridge Rd and FedEx Drive, Lower Chichester, PA and ends Northeast of Flower St and Delaware Ave, City of Chester, PA

Project Description: The Tilghman lateral pipeline, known as Phase 2B of the Adelpia Gateway Lateral Project, consists of approximately 4.4 miles of a 16-inch O.D. pipeline. The installation consists of open cut for approximately 0.6 miles and horizontal directional drill (HDD) for approximately 3.8 miles. The Tilghman Lateral runs along Ridge Road from National Ave to Langley Street and extends out of the right-of-way towards Price Street where the lateral continues Northeast along West 2nd Street to Flower Street. The Tilghman Lateral ends at the PECO Meter Station along Delaware Ave.

A notification was sent to your office on June 11, 2020 for this segment of the Tilghman Lateral. A resubmission of plans and NOI are included in this package, which notes an additional 23.5 acres added for temporary workspaces. The workspaces are intended for parking, staging materials and equipment, pipe stringing and welding, and stockpiling. The open cut trenching accounts for 1.3 acres of the LOD. Mechanical piping and two buildings are proposed at the PECO Meter Station where the Tilghman Lateral ends. The entire limit of disturbance for the Tilghman Lateral section will be restored to existing conditions and site restoration and PCSM devices (two dry wells) are proposed at the PECO Meter Station.

Enclosed is a complete copy of the Notice of Intent (NOI) completed by the applicant for this project as well as a copy of the Erosion and Sediment Control/Site Restoration plan.
