Dear Mr. Smith:

Please find enclosed a Department of Environmental Protection (DEP) Plan Approval to construct, modify, reactivate, or install an air cleaning device on an air contamination source. This Plan Approval contains special conditions which must be fulfilled. Failure to do so violates Section 127.25 of DEP rules and regulations, which may result in enforcement action and denial of an Operating Permit.

A DEP Operating Permit will be issued $\underline{if}(l)$ the special conditions incorporated within the Plan Approval have all been fulfilled; (2) DEP is satisfied that the project was carried out as proposed in the application, and that the operation of the source(s) and any associated air pollution control equipment conforms with the operational information stated on the application; and (3) the DEP is satisfied that the air contaminant emissions from the source(s) comply with the requirements specified in, or established pursuant to, all applicable DEP rules and regulations.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board), pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:

Appeals must be filed with the Board within 30 days of receipt of notice of this action unless the appropriate statute provides a different time. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.

IF YOU WANT TO CHALLENGE THIS ACTION, YOUR APPEAL MUST BE FILED WITH AND RECEIVED BY THE BOARD WITHIN 30 DAYS OF RECEIPT OF NOTICE OF THIS ACTION.
