On October 13, 2017, the Pennsylvania Department of Environmental Protection (“DEP”) received a response to DEP’s May 30, 2017, administrative completeness review letter regarding the above referenced Phase II application from Elcon Recycling Services, LLC (“Elcon”) for a Resource Conservation and Recovery Act (RCRA) Part B Permit for a proposed commercial hazardous waste storage and treatment facility that is to be located at 100 Dean Sievers Place within the Keystone Industrial Port Complex (former United States Steel Fairless Works site) in Falls Township, Bucks County.


Applications submitted to DEP undergo a series of reviews. The referenced administrative completeness review response for Elcon’s Phase II application is currently undergoing administrative completeness review, the results of which will be relayed to Elcon at a later date, in accordance with Section 309(d) of the Hazardous Sites Cleanup Act, 35 P.S. § 6020.309(d).

By copy of this letter, we are forwarding copies of Elcon’s administrative completeness review response to Falls Township and Bucks County Health Department for information only, at this time. The Township and the County will be informed by separate letter when Elcon’s Phase II RCRA Part B application is considered to be administratively complete so that they may commence their technical review at that time. Also by copy of this letter, we are forwarding a copy of the administrative completeness review response to U.S.E.P.A Region 3 and to the Levittown Branch of the Bucks County Library. Elcon has indicated that it will place a copy of its response in the Burlington County Library in Westampton, New Jersey. DEP will also be posting an electronic copy of Elcon’s response on the web at <http://www.dep.pa.gov/About/Regional/SoutheastRegion/Community%20Information/Pages/Elcon-Recycling-Services-LLC.aspx> in the near future. The afore-mentioned copies do not include the Confidential Business Information claimed by Elcon at this time.

This confidentiality claim is subject to further review by DEP, and its availability will be determined at a later date.
