Dear Mr. Warmann:

On August 19, 2025, MIPC, LLC informed the Department of Environmental Protection (DEP) of a release of gasoline at its Chelsea Pipeline Station and Tank Farm in Bethel, Upper Chichester, and Aston Townships, Delaware County. On December 15, 2025, MIPC, LLC reported that a release had been identified from a storage tank at the facility. This release has contaminated soil and groundwater.

Pursuant to Sections 316 and 610 of the Clean Streams Law, 35 P.S. §§ 691.316 and 691.610; Section 10.1 of the Air Pollution Control Act, 35 P.S. § 4010.1; and Section 1917-A of the Administrative Code; and the rules and regulations adopted pursuant to each, DEP is issuing the attached administrative order directing MIPC, LLC to respond to the storage tank release and implement remedial actions in accordance with that order.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board), pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:

Appeals must be filed with the Board within 30 days of receipt of notice of this action unless the appropriate statute provides a different time. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.
